Dear Members of the City Council:

I regret not being able to attend the May 2 meeting where you will conduct interviews to determine qualifications of applicants for service on the Library Board of Trustees. My plans to be elsewhere were made long before I was asked to submit an application. I was advised that a brief letter stating my reasons for wanting to serve on the Board and my qualifications would suffice in lieu of an in-person appearance.

I recall going on a school trip at the age of 6 to the Pasadena Public Library, certainly one of the most beautiful libraries in the world. I stood on the tile floor in the main hall looking with awe at the majesty of this place devoted entirely to the world of books. And when I was told that I could take some of these books home with me to read I was certain that I had been transported to heaven!

I have been in love with books and libraries ever since. I believe this experience and the encouragement I received during my formative years from librarians, teachers and other book lovers was primary in my decision to become a scholar and a teacher. I passed this love of learning on to my child and I hope that I have transmitted this joy to at least some of the thousands of students I have taught during my nearly 50 years as a professor of philosophy.

Now that I am deep into my retirement I would like to continue this journey by connecting to an institution or a program which helps to support and encourage the growth of libraries.
