SUBJECT: **Rambouillet Road Rehabilitation**

---

**NEEDS:** For City Council to consider awarding a contract for rehabilitation of Rambouillet Road from Niblack to Nicklaus.

**FACTS:**

1. On September 18, 2012, City Council adopted Resolution No. 12-160 allocating \$748,963 in Highway User Tax Account (HUTA) funds received from the State for resurfacing of Rambouillet from Niblack to Nicklaus.
2. The maintenance treatment for the road is to pulverize about 6 inches of the road surface, re-compact, and place a 3.5-inch Hot Mix Asphalt (HMA) overlay.
3. During the design phase, it was determined that the road profile was flat, causing water to pond, which through the years has affected the road's structure. As part of the maintenance project, the street profile requires a re-design to prevent water ponding. Because of the revised profile, the curb ramps were affected and need to be reconstructed.
4. At the bid opening on May 9, 2013, six bids were received as follows:

**ANALYSIS & CONCLUSION:** Staff reviewed the low bid submitted by CalPortland and found it to be a responsive and responsible bid.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES  
AWARDING A CONTRACT MAINTENANCE AND REHABILITATION  
OF RAMBOUILLET ROAD, FROM NIBLICK TO NICKLAUS

WHEREAS, on September 18, 2012, City Council adopted Resolution No. 12-160 allocating \$748,963 in Highway User Tax Account (HUTA) funds received from the State for resurfacing of Rambouillet from Niblick to Nicklaus; and

WHEREAS, during the design phase of the rehabilitation work, it was determined that the street profile needs to be re-designed to prevent water ponding; and

WHEREAS, the bid documents included curb ramp reconstruction to adjust for the street profile changes; and

WHEREAS, at the bid opening on May 9, 2013, six bids were received ranging from \$581,167.21 to \$743,310.76; and

WHEREAS, staff reviewed the low bid submitted by CalPortland and found it to be a responsive and responsible bid.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of Paso Robles does hereby award the contract for rehabilitation and maintenance of Rambouillet Road, from Niblick to Nicklaus, to CalPortland Company in the amount of \$581,167.21, and authorizes the City Manager to execute the contract.
