NEEDS: Consider an agreement with the County of San Luis Obispo for Animal Control

Services, July 1, 2013 - June 30, 2016 in the amount of \$308,482.

1. The City of Paso Robles contracts with the County of San Luis Obispo Animal Services Division for animal control services.

- 2. The current contract for animal services, in the amount of \$271,035, expired June 30, 2013.
- 3. Every year a comprehensive Animal Services Study (see attached) is completed to examine the costs attributed to each contracting municipality.
- 4. The study completed this year once again identified the full cost recovery for each municipality to use services from the County of San Luis Obispo for animal control.
- 5. The final contract rate for animal services for the City of Paso Robles was set at \$308,482.

ANALYSIS &

FACTS:

CONCLUSION: The City has contracted with San Luis Obispo County for animal control services for many years. The contract includes: response of Animal Service Officers for injured or stray animals; investigative services for animal bites, abuse and neglect; sheltering and quarantine services; dog licensing; animal adoption; and other services as required by either State law or City Municipal Code. The most recent contract with the County expired June 30, 2013, as did all other incorporated cities' contracts.

Every year County Administration and Finance, County Health Agency, County Animal Services and all local police chiefs participate in a comprehensive study of Animal Control Services and associated costs. During the study process this year, it was determined the level of service to the City of Paso Robles has increased since the last contract period.

The results of the Animal Services Study this year revealed program costs are reasonable and the method of data collection and attribution to individual cities is accurate. Certain cities use Animal Services at a significantly higher rate than others and the City of Paso Robles is currently the highest user of services of all the contracting municipalities.

Based on the most current Animal Services Study, the final contract rate identified for the City of Paso Robles during the first year of the contract is \$308,482. Contract pricing for will be adjusted for inflation each year after the first year of the contract, but large adjustments are not anticipated.
