Groundbreaking for the Uptown Family Park was held. Dahlen is working on a new city flag design, and also working with Christiansen on Black Gold Library Cooperative matters.

-Karen Christiansen updated the Board on potential dates for the State Library in-service for board members. She also discussed a potential meeting of the Friends/Library Foundation/Library Board sometime in early 2014.

-Trustee Sequeira asked about repairs/replacement of the microfilm reader. Christiansen reported that due to the cost it is not scheduled to be repaired or replaced at this time. -President Alch inquired about the self-checkout machine; repair for that machine is in the works.

3. <u>Public Art Policy</u> – Dale Evers

Dahlen reviewed the public art policy, and explained that the Parks and Recreation Advisory committee is the screening body for recommendations of artwork display for city council consideration. The city has a modest park fund of \$600.

Dale Evers proposed his idea for the community:

- Five pedestals made out of steel (With temporary art display to be decided every 24 months)
- Start with pedestal in front of Dale Evers Design Studio on 13th Street
- Pedestals are \$200 each- can be funded by local business
- Art could be donated by local artists

Advisory committee is open to proposed art idea, asked Evers to return with more defined details on:

- Liability insurance
- Maintenance of art
- Safety/Traffic issues
- ADA issues
