For the City Council to consider appointment for a partial term to the Travel Paso NEEDS:

Robles Alliance (TPRA) Advisory Committee.

FACTS: 1. The Travel Paso Robles Alliance (TPRA) was established in 2009 in conjunction with the formation of the Tourism and Lodging Promotions Business Improvement District (BID).

- 2. The TPRA consists of seven members who advise City Council on the marketing/spending priorities for funds generated by the BID.
- 3. Members are appointed for 3-year staggered terms, and must be a hotelier to be eligible for membership on the TPRA.
- 4. Advisory Member Shawn Styler was appointed to a 3-year term that would be expiring on October 31, 2014. Mr. Styler has tendered his resignation from the TPRA effective December 1, 2013.
- 5. The TPRA's contracted Destination Manager contacted hoteliers to recruit those who might be interested in applying to serve on the TPRA. Two local hotel representatives indicated their interest:

Brittany Tonkin – Assistant General Manager, Courtyard Marriott John Arnold - General Manager, Holiday Inn Express & Suites

At their meeting of November 26, 2013, the TPRA interviewed the two 6. interested hoteliers. On a 5-0 vote, the TPRA recommended the City Council appoint John Arnold to the vacant remaining (11 month) term.

ANALYSIS

AND

CONCLUSION:

The focus of the TPRA's discussion after interviewing the two candidates, was to see an appointee with experience serving on committees and with established relationships in the community. The TPRA also indicated their commitment to orient additional hoteliers to the committee's work in order to grow the pool of experienced member candidates for the future.
