SUBJECT:	Turtle Creek Asphalt Sidewalk Improvements, Contract Award

NEEDS: For City Council to consider awarding a contract to improve the asphalt pedestrian path adjacent to Turtle Creek in the Sierra Bonita residential development.

FACTS:
 In the late 1970s/early 1980s an asphalt sidewalk was installed on the north side of Brookhill Road in Turtle Creek Park. This is a linear park that follows a creek and offers passive recreation (walking and picnic tables) primarily to senior-aged residents of the Sierra Bonita subdivisions on either side. Over the last 30 years, the asphalt walkway has been damaged by tree roots, wear and tear. It now presents a tripping hazard.

The project consists of removing the existing asphalt walkway and replacing it with a more durable portland cement concrete sidewalk. The estimated length is 2,000 linear feet. Minor re-grading may be necessary to prepare the base and remove tree roots and to upgrade ramps to comply with ADA requirements.

- 2. On May 17, 2011, City Council authorized staff to proceed with preparation of bid documents to improve the path.

CONCLUSION:

Staff reviewed the low bid submitted by Andrew Brown General Engineering and found it to be a responsive and responsible bid.

POLICY REFERENCE:	Resolution No. 11.064 authorizing staff to design and prepare bid documents to improve the sidewalk adjacent to Turtle Creek.
FISCAL IMPACT:	The project is listed in the City's Community Development Block Grant (CDBG) program to receive funding under Budget No. 227.910.5452.386. A total of \$217,000 is available. Besides the construction contract (\$152,728.30) the remainder will be used for construction surveying, soils compaction testing, review of submittals, responding to requests for design clarifications, arborist services to monitor work around existing oak trees, and some contingency.
