### SUBJECT: Congestion Mitigation Air Quality Grant

- DATE: June 3, 2014
- **NEEDS:** For City Council to consider accepting a Congestion Mitigation Air Quality (CMAQ) grant for Union Road/Golden Hill Road to Highway 46 bike lanes and associated improvements.
- FACTS:1. In August 2013, San Luis Obispo Council of Governments (SLOCOG) issued a call for project nominations to program funding for several State and Federal grants.
  - 2. On April 2, 2014, the SLOCOG Board adopted a list of projects to be programmed with a Congestion Mitigation Air Quality (CMAQ) grant. One of the projects on the list is the Union Road Widening and Bike Lane improvements from Golden Hill Road to Highway 46, in the amount of \$877,000. This segment of road is scheduled for maintenance in Summer 2016 using Supplemental Sales Tax revenue, which was used as a "match" for the CMAQ grant.

### ANALYSIS &

**CONCLUSION:** The attached resolution would formally accept the grant, which will be used with Supplemental Sales Tax funds, for the future construction of Union Road/Golden Hill to Highway 46.
