- According to City Planning and Public Works staff, Class 2 bike lanes -- 5' striped and painted with bike arrows – are not to be included in the scope of the current Riverside project.
- According to Fleury, Class 2 lanes are crucial on Riverside as a link to other bike lanes and trails.

Moved/seconded by Perino/Iaquinto to endorse the inclusion of Class 2 bike lanes on Riverside Avenue; motion carried.
