2. Bid documents were prepared and at the bid opening on May 29, 2014 seven bids were received as follows:

3. The City received a bid protest from Souza Construction dated June 3, 2014. G. Sosa responded to the protest in a letter dated June 4.

ANALYSIS &

CONCLUSION: Staff reviewed the low bid submitted by G. Sosa and found it to be a responsive and

responsible bid. Staff and the City Attorney reviewed the protest and response and

determined that the protest was without merit.

POLICY

REFERENCE: Resolution No. 14-015 adopted by City Council approving the final design and allocating a

budget for the project.

FISCAL

IMPACT: On February 4, 2014, City Council allocated \$2,836,500 for the project of which \$533,500

is from a Bicycle Transportation Act (BTA) grant and \$297,000 from an Urban State Highway Act (USHA) grant. The remainder is coming from a combination of Union/46

Specific Plan, Water Operations, Supplemental Tax, and Gas Tax funds.

OPTIONS: a. Adopt Resolution No. 14-xx finding that the bid protest filed by Souza Construction

is without merit, and awarding a contract for Union Road Improvements (Kleck to Montebello Oaks) to G. Sosa Construction in the amount not to exceed

\$1,914,017.00, and authorize the City Manager to execute the contract.

b. Amend, modify, or reject the above option.

<u>SECTION 2.</u> The City Council does hereby award a construction contract to G. Sosa Construction, Inc. in the amount of \$1,914,017.00 for road improvements to Union Road from Kleck to Montebello Oaks, and authorizes the City Manager to execute the contract.
