NEEDS:	For the City Council to consider adopting amendments to the Business License Code.		
Facts:	1. The City requires every business that operates within the City to pay a business license tax and obtain a business license.		
	2. The City's business license ordinance does not allow licensing of fortunetelling.		
	3. The City Council recently amended the City Code Chapter 5.16 to allow fortunetelling and related services in commercial and office professional zones, subject to a conditional use permit.		
	4. The attached ordinance would require fortunetelling and other related services to be subject to the same business license requirements as other special service businesses.		
Analysis & Conclusion:	The City Council recently approved an amendment to the Municipal Code allowing Fortunetelling and related services in commercial and office professional zones, subject to a conditional use permit.		
	In order to allow such a business, the Business License ordinance needs to also be amended, such that fortunetelling and related services would be subject to the same business license requirements as other special service businesses.		
Fiscal Impact:	This would have minimal financial impact for the City.

ORDINANCE NO. XXX N.S.

AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES AMENDING CHAPTER 5.16 AND SECTION 5.04.230 OF THE MUNICIPAL CODE REGARDING FORTUNETELLING

WHEREAS, the City of El Paso de Robles ("City") requires every business that operates within the City to pay a business license tax and obtain a business license; and

WHEREAS, Chapter 5.04 of the EI Paso de Robles Municipal Code ("Municipal Code") sets forth the procedures and requirements most businesses must comply with to obtain a business license; and

WHEREAS, Chapter 5.16 of the Municipal Code requires fortunetelling businesses to follow special procedures to obtain a business license; and

WHEREAS, Chapter 5.16 of the Municipal Code restricts fortunetelling businesses to certain zones and types of buildings; and

WHEREAS, the City Council is in the process of amending the Municipal Code to allow fortunetelling and related services in commercial and office professional zones, subject to a conditional use permit; and

WHEREAS, the City Council would like to revise Chapter 5.16 to eliminate the zoning and building restrictions for fortunetelling businesses and to revise Chapter 5.04 and Chapter 5.16 to require that fortunetelling businesses be subject to the same business license requirements as other personal service business.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Recitals. The above recitals are incorporated as though set forth in this section.

<u>SECTION 2.</u> <u>Amendment.</u> Section 5.04.230 of the EI Paso de Robles Municipal Code is hereby amended to read in full as follows:

5.04.230 License tax—Flat amount—Businesses liable.

Every business performing service with no retail sales herein enumerated shall pay an annual license tax as follows:

<u>SECTION 3.</u> <u>Amendment.</u> Chapter 5.16 of the El Paso de Robles Municipal Code is hereby amended to read in full as follows:

5.16.010 Reserved.
5.16.020 License — Application.
5.16.030 License fee.
5.16.040 Penalty for violation.

5.16.010 Reserved.

5.16.020 License—Application.

No license shall be granted for fortunetelling, clairvoyance, astrology, palmistry, phrenology, card reading, cartomancy, crystal gazing, mediumship prophesy, augury, divination, magic, hypnotism and necromancy until an applicant for such license has followed the application procedures and requirements outlined in Chapter 5.04.

5.16.030 License fee.

For conducting any business described in this chapter the license tax shall be at the rate of thirty six dollars per year.

5.16.040 Penalty for violation.

Any violation of this chapter shall constitute a misdemeanor, and any person found guilty thereof shall, upon conviction or plea of guilty, be punishable by a fine of not more than \$1,000 or by imprisonment for not more than six months, or by both such fine and imprisonment.

<u>SECTION 4.</u> Severability. Should any provision of this Ordinance, or its application to any person or circumstance, be determined by a court of competent jurisdiction to be unlawful, unenforceable or otherwise void, that determination shall have no effect on any other provision of this Ordinance or the application of this Ordinance to any other person or circumstance and, to that end, the provisions hereof are severable.

<u>SECTION 5.</u> <u>Effective Date.</u> This Ordinance shall take effect thirty (30) days upon its final passage as provided in section 36937 of the Government Code.

<u>SECTION 6.</u> <u>Publication.</u> The City Clerk will certify to the passage of this Ordinance by the City Council of the City of El Paso de Robles, California and cause the same to be published once within fifteen (15) days after its passage in a newspaper of general circulation, printed, published and circulated in the City in accordance with Government Code section 36933.

<u>SECTION 7.</u> <u>Inconsistency.</u> To the extent that the terms or provisions of this Ordinance may be inconsistent or in conflict with the terms or conditions of any prior City ordinance(s), motion, resolution, rule, or regulation governing the same subject matter thereof, such inconsistent and conflicting provisions of prior ordinances, motions, resolutions, rules and regulations are hereby repealed.
