Facts:

- City equipment, from time to time, is declared surplus due to age, cost of maintenance and/or obsolescence.
- 2. The property listed in Exhibit A is no longer serviceable or needed for City operations.
- 3. Disposal of said equipment cannot take place until formally declared surplus by the Council.
- 4. Proceeds from the sale of the surplus equipment will be deposited back into the General Fund, Equipment Replacement Fund, or the appropriate Enterprise Fund.
