

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES ANNEXING PARCELS 2, 3 AND 4 OF PARCEL MAP PR 03-0338 TO THE CITY'S COMMMUNITY FACILITIES DISTRICT NO. 2005-1

WHEREAS, the owner of the real property described in Exhibit 'A' has petitioned to annex Parcels 2, 3 and 4 of Parcel Map PR 03-0338 into the Paso Robles Community Facilities District No. 2005-1 (Public Services).

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

<u>SECTION 1.</u> That the City Council of the City of Paso Robles does hereby declare that the real property located in the City of Paso Robles, County of San Luis Obispo, as more particularly described in Exhibit "A" hereto, is hereby annexed into Community Facilities District 2005-1 and that the subject properties shall be subject to a tax lien of \$827.68 per dwelling unit per year, which, in turn, is subject to escalation based on a blend of the San Francisco Urban Consumer Price Index and Los Angeles Urban Consumer Price Index or two percent, whichever is greater.

<u>SECTION 2.</u> That the City Council of the City of Paso Robles does hereby declare that the current owner of the real property, according to the Consent and Election to Annex Real Property to an Existing Community Facilities District Petition for Formation of the District, is Harrod Paso, LP.

<u>SECTION 3.</u> That the City Council for the City of Paso Robles does hereby declare that the assessment for Parcels 2, 3 and 4 of Parcel Map PR 03-0338 shall begin with Fiscal Year 2014-2015.

<u>SECTION 4.</u> That the City Council for the City of Paso Robles does hereby declare that the area annexed shall be designated as Annexation No. 05-047 to the Paso Robles Community Facilities District No. 2005-1.
