**SUBJECT: Union Road Project – Expanded Scope of Work**

**NEEDS:** For City Council to consider extending the Union Road Improvements Project from Montebello Oaks to Prospect Avenue.

**FACTS:**

1. City Council awarded the construction contract for Union Road improvements, between Kleck and Montebello Oaks.
2. The work is under way and is about 30% complete.
3. Staff reviewed the road surface from Montebello Oaks to Prospect Avenue and found that this segment requires improvements. In some areas the surface has deteriorated and in others there is reflective cracking.

**ANALYSIS & CONCLUSION:** It would seem prudent to extend the project limits to Prospect Avenue

**POLICY REFERENCE:** None

**FISCAL IMPACT:** On February 4, 2014, the City Council allocated \$2,836,500 to the project. Cost to extend the project limits to Prospect Avenue is estimated to be \$150,000. The budget adopted in February 2014 for the project has adequate funds for this additional work.

**OPTIONS:**

- a. Adopt Resolution No. 14-xx authorizing a Contract Change Order to the Union Road Improvements project, in the amount of \$150,000, to extend the project limits to Prospect Avenue; or
- b. Amend, modify, or reject the above option.
