NEEDS: For the City Council to consider updating telephone equipment software to maintain usability for the balance of the life span.

FACTS:

- 1. The City installed the current telephone system in 2008 expecting a 10 year life for the core of the system.
- 2. In 2009 the City canceled the \$2760/monthly maintenance contract and utilized internal staff for all system maintenance saving \$182,000 (in the last 66 months).
- 3. Additional telephones are needed with the wastewater treatment plant expansion, new water treatment plant and to replace 20 broken phone sets.
- 4. The manufacturer no longer sells this model of telephone, software and license. Updates to the system core must be compatible with newer phones.
- 5. For support purposes, the manufacturer requires the phone system to run a recent version of the software. Because of the out-of-date software, a major system problem would expose the City to prolonged downtime.
- 6. The City to purchase
 - a. Upgrade Avaya IP Office from version 4.1 to 9.1
 - b. Three V2 processors and two PRI cards
 - c. 184 Upgraded Voicemail software licenses
 - d. 184 Avaya Endpoint licenses (one for each phone)
 - e. Installation and configuration of software and hardware
- 7. The City requested a quote to bring the telephone system up-to-date from the original installation vendor.

ANALYSIS &

CONCLUSION: The City adopted equipment replacement policy is based on the useful life of the equipment; however technology often requires software updates to maintain functionality and compatibility. By utilizing City staff instead of contracting, the City has generated a savings amount much greater than the cost to update.

The city's computer equipment replacement fund has sufficient funds to perform the \$21.528 update/upgrade. This investment is expected to extend the usability/viability of the current phone system for the balance of its projected lifespan.


