SUBJECT: Long-Term Parking Lot at Former Boatel Mini-Storage

DATE: December 2, 2014

NEEDS: For City Council to consider awarding a contract to construct a long-term parking lot at

the former Boatel Mini-Storage units on Pine Street.

FACTS: 1. On September 2, 2014, the City Council reviewed the final design of a long-term parking lot at the former Boatel Mini-Storage units.

2. City Council approved the final design and directed staff to advertise for bids.

3. At the bid opening on November 6, 2014, seven bids were received as follows:

CalPortland	\$ 599,961.75
T. Simons	622,722.50
Pickard & Butters	636,862.07
Whitaker	653,580.20
Souza	658,000.00
Raminha	668,218.00
Spiess	748,864.00

Analysis & Conclusion:

Staff reviewed the bids received and found an error in the bid submitted by T. Simons. Adding up the individual bid items, the total bid amount was \$582,985.42, making this the apparent low bid. Staff notified CalPortand and T. Simons of this new outcome (CalPortland was the apparent low bidder prior to discovery of the bid error). CalPortland subsequently filed a bid protest. T. Simons reviewed their bid and determined an error had been made transferring data, and they cannot do the project for \$582,985.42. They asked that the City grant them relief from their bid.

The above facts were reviewed by the City Attorney's office; they recommend that City Council adopt the attached resolution stating that they:

- grant relief to T. Simons due to a material error,
- reject CalPortland's bid protest as moot,
- award the contract to CalPortland Construction.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES AWARDING A CONTRACT TO CONSTRUCT A LONG-TERM PARKING LOT AND ALLOCATING PROJECT FUNDS

WHEREAS, on September 2, 2014, City Council approved the design of a long-term parking lot at the former Boatel Mini-Storage units on Pine Street, and directed staff to advertise for bids; and

WHEREAS, at the bid opening November 6, 2014, seven bids were received ranging from \$599,961.75 to \$748,864.00; and

WHEREAS, staff reviewed the bids and discovered an error in the T. Simons bid, which brought their bid total to \$582,985.42; and

WHEREAS, staff notified the two lowest bidders, CalPortland and T. Simons, of the change in bid outcome; and

WHEREAS, CalPortland filed a bid protest; and

WHEREAS, T. Simons reviewed their bid, discovered the source of their error and asked the City for bid relief as they could not do the project for the revised/lowered bid price; and

WHEREAS, staff reviewed the low bid submitted by CalPortland Construction and found it to be a responsive and responsible bid; and

WHEREAS, City Council allocated a project budget of \$1,030,000 at their May 20, 2014 meeting.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

<u>SECTION 1.</u> The City Council of the City of Paso Robles does hereby grant relief to T. Simons from their bid, due to a material error.

<u>SECTION 2.</u> The City Council does hereby reject CalPortland Construction's bid protest as moot.

<u>SECTION 3.</u> The City Council does hereby award a contract to construct a long-term parking lot at the former Boatel Mini-Storage on Pine Street to CalPortland Construction in the amount of \$599,961.75, and authorizes the City Manager to execute the contract.
