Needs:

For the City Council to make budget appropriations for projects to be accomplished with the City's allotment of 2014 Community Development Block Grant (CDBG) funds.

Facts:

1. At its meeting of February 4, 2014, the City Council adopted Resolution 14-009 determining that the following activities are to be funded with the City's 2014 allotment of Community Development Block Grant (CDBG) funds (which were estimated to be \$152,240):

Handicapped Ramps\$	99,400
El Camino Homeless Organization\$	22,836
Capacity Building (an administrative use of CDBG funds)\$	15,000
Administration\$	15,000
Total\$	152,240

2. In April 2014, the County notified the City that the US Department of Housing and Urban Development (HUD) had determined that the City's 2014 Allocation of CDBG funds would be increased to \$165,079. As provided in Section 2 of Resolution 14-009, the City Manager administratively adjusted the allocations as follows:
