SUBJECT: Vehicle and Equipment Replacement

DATE: September 1, 2015

# **NEEDS**: For the City Council to consider replacing vehicles and equipment consistent with the City's Equipment Replacement Program/Policy.

#### FACTS:

- 1. The FY15/16 replacement list is comprised of equipment necessary to support Police, Utilities and Maintenance tasks.
- 2. The City has been very conservative in its replacement of vehicles and equipment throughout the recession. Vehicles and equipment have remained in use past adopted replacement schedules and useful life in order to preserve cash during the recession.
- 3. The equipment recommended for replacement is evaluated based upon:
  - a. Age and run time hours for medium and heavy equipment.
  - b. Adopted policy:
    - 1. Police patrol cars are replaced every three years or 80,000 miles, whichever occurs first.
    - 2. Trucks and other vehicles are replaced every ten years or 80,000 miles.
  - c. Productivity of the equipment: if the aged equipment due for replacement is not projected to be used effectively in the future, the replacement equipment is proposed to be an item that will aid work efficiency.
- 4. Prices for replacement vehicles were compiled using the State and/or Governmental Agency Cooperative bidding.

#### ANALYSIS &

**CONCLUSION**: The City adopted equipment replacement policy is based on the useful life of the equipment.

Additionally, equipment is examined to determine if the useful life can be extended and/or the equipment can still satisfy the needs it was intended. The FY15/16 requested purchases are limited to equipment or vehicles essential to life/safety and maintenance operations for which the useful equipment life has been exhausted, become ineffectual or obsolete.

The Council Ad Hoc committee did review the replacement equipment replacement list on August 13, 2015. Their recommendations to remove two generators from the

list and investigate Grant funding for next year have been incorporated into the final list included with this staff report.

**IMPACT**: The Fiscal Year 2014/2015 Vehicle/Equipment replacement list includes 25 requested vehicles and/or pieces of equipment (see Attachment "A"). Equipment needs by fund as follows.

The City's General Equipment Replacement Fund contains \$1,600,000.

The City's Utility Funds contain \$23,000,000 in retained earnings.

WHEREAS, the City has adopted vehicle replacement policies based on the useful life of the vehicles/equipment; and

WHEREAS, prices were compiled using the State bid list and Governmental Agency Cooperative bidding to achieve the lowest cost possible.
