**SUBJECT:** Street Sweeping  
**DATE:** December 1, 2015

---

**NEEDS:** For City Council to consider rejecting all bids and re-advertising the contract to provide Citywide Street Sweeping Services.

- FACTS:**
1. On August 5, 2014, City Council authorized a contract for Citywide Street Sweeping Services with SP Maintenance Services. The contract term was 1 year with an option, by mutual consent, for an additional 3 years.
  2. SP Maintenance Services declined the option to renew their contract.
  3. Street sweeping services was re-bid, and on November 5, 2015, three bids were received:

SP Maintenance Services .....	\$ 85,099.32
CleanStreet .....	\$ 107,671.71
Contract Sweeping Services .....	\$ 120,180.48
  4. The Notice Inviting Bids and Information for Bidders, each a part of the bid documents, provide that the City reserves the right to reject any or all bids in what the City alone considers to be in the best interests of the City.

**ANALYSIS & CONCLUSION:** The interests of the City would be best served by reevaluating and refining the street sweeping scope of work. It is recommended that Council reject all bids and authorize staff to make adjustments to the project and re-advertise.

**POLICY REFERENCE:** Paso Robles Municipal Code Section 6.04.340

**FISCAL IMPACT:** The fiscal impact is limited to the cost of bid advertising, estimated at \$900.

- OPTIONS:**
- a. For the City Council to approve Resolution 15-XXX rejecting all bids for street sweeping services and authorizing staff to make adjustments to the project and re-advertise.
  - b. Amend, modify, or reject the above option.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES  
REJECTING ALL BIDS FOR PROVISION OF CITYWIDE STREET SWEEPING SERVICES  
AND AUTHORIZING RE-ADVERTISEMENT OF BIDS

WHEREAS, on August 5, 2014, City Council authorized a contract with SP Maintenance Services for provision of Citywide Street Sweeping Services for a term of 1 year with the option for an additional 3 years; and

WHEREAS, SP Maintenance Services declined the option to renew their contract at the end of the initial year; and

WHEREAS, street sweeping services was re-bid, and at the bid opening on November 5, 2015, three bids were received -- \$85,099.32, \$107,671.71 and \$120,180.48; and

WHEREAS, the Notice Inviting Bids and Information for Bidders provide that the City reserves the right to reject any or all bids in what the City alone considers to be in the best interests of the City; and

WHEREAS, the interests of the City would be best served by reevaluating and refining the street sweeping scope of work.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of El Paso de Robles does hereby reject all bids received for provision of Citywide Street Sweeping Services.

SECTION 2. The City Council does hereby authorize staff to adjust the street sweeping scope of work and re-advertise the project for bids.
