SUBJECT: Time Limits for No Parking for Farmers Market, 11th Street

DATE: February 16, 2016

Needs: For the City Council to consider establishing hours of “No Parking” on 11th Street between Spring Street and Park Street to accommodate the Tuesday and Saturday Farmers Markets.

Facts:

1. On Tuesday, January 19, 2016, contractors retained by the City broke ground on the rehabilitation of Downtown Park.
2. With on-going construction and the establishment of new improvements of the Park, it is necessary that the Farmers Markets be permanently moved into the paved area of 11th Street between Spring Street and Park Street.
3. Moving the Farmers Markets onto the street will protect the investment of new Park improvements, and will provide for a better location for the Market’s long-term operations.
4. Moving the Farmers Markets onto 11th Street will require establishing No Parking between the hours of 2:00 PM to 6:00 PM on Tuesday, and 7:00 AM to 2:00 PM on Saturday.
5. Formally establishing the hours of No Parking will authorize the placement of permanent signs, replacing the less attractive paper signs now placed on a weekly basis.
6. The proposed No Parking will affect both sides of 11th Street from Spring Street to Park Street and should temporarily impact only park and library visitors.

Analysis &
Conclusion: The Farmers Markets have successfully operated on the south side of the Park on Tuesdays and Saturdays for at least ten years. With the on-going construction of Park improvements, it is necessary that the Market operations be relocated onto the street surface. For the long-term, it is essential to keep the Market trucks away from the existing turf and new walkways for protection of the investment in Park improvements.

For Market operations on 11th Street it is necessary to establish hours of No Parking. Proposed hours are between 2:00 PM to 6:00 PM on Tuesdays and 7:00 AM until 2:00 PM on Saturdays. The No Parking will be in effect on both sides of 11th Street from Spring Street to Park Street.

Impact: Minor costs for the fabrication of the permanent signage.

- Options:
- a. The City Council to adopt Resolution No. 16-xxx establishing “No Parking” on both sides of 11th Street between Spring Street and Park Street between the hours of 2:00 PM until 6:00 PM effective Tuesdays and 7:00 AM until 2:00 PM effective Saturdays for the purposes of allowing the Farmers Market.
 - b. The City Council amend the above option.
 - c. Amend, modify, or reject the above options.
 - d. Take no action.

RESOLUTION NO. 16-XXX

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF PASO ROBLES ESTABLISHING HOURS OF NO
PARKING FOR OPERATION OF FARMERS MARKETS ON 11TH STREET

WHEREAS, on December 1, 2015, the City Council of the City of Paso Robles awarded a contract for downtown park improvements in the amount of \$1,075,700; and

WHEREAS, with on-going construction and the establishment of new improvements in the Park, it is necessary that the Farmers Markets be permanently relocated onto the pavement surface of 11th Street; and

WHEREAS, moving the Farmers Markets onto 11th Street between Spring Street and Park Street will protect the investment of Park improvements and will provide for reasonable and sustainable maintenance of the Market's operations; and

WHEREAS, moving the Farmers Markets onto 11th Street between Spring Street and Park Street will require establishing hours of No Parking to accommodate the Market's hours of operation.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council of the City of El Paso de Robles does hereby establish No Parking on both sides of 11th Street, from Spring Street to Park Street between the hours of 2:00 PM to 6:00 PM every Tuesday during the calendar year.

SECTION 2. The City Council of the City of El Paso de Robles does hereby establish No Parking on both sides of 11th Street, from Spring Street to Park Street between the hours of 7:00 AM to 2:00 PM every Saturday during the calendar year.
