BUSINESS ITEMS

2. **Parks 4 Pups** – (Larry Miller)

Larry Miller of Parks 4 Pups is seeking an endorsement for pouring additional concrete paths at the Sherwood Dog Park.

- The Dog Park has been in operation for four years on property leased from the City for \$1 per year.
- Group interested in completing cement work that was started last year, from gate and cement path from top of steps
- Need to add 800 sq. ft. more cement to existing to complete job.

Advisory committee concerns:

- ADA compliance.
- Temporary park due to Sherwood Park Master Plan.
- Lease is up for renewal in less than one year.
- Tennis groups not in favor of concrete due to tennis courts in Master Plan.
- Committee requested seeing wording on lease agreement before making final decision.

Finley made a motion to table decision until we have information regarding Lease for Parks 4 Pups, Orlando seconded- motion carried.

3. **Advocacy Activities/Opportunities** (*Taranto*)
 - Perino was at BSP tournament; impressed with cleanliness of park
 - Perino attended Commissioners' Workshop sponsored by SLO County Association of Professional Recreation Administrators.
 - Janes attended a basketball game at Centennial gym, concerned with blown out lights on scoreboard; Dick McKinley made a notation to check all lights.
 - Orlando stated that the walkway path on trail is dangerous due to metal edges exposed on table and bench
 - Finley mentioned PD not happy with BSP parking, suggested painting areas of the curb red, Freda Berman and Dick McKinley are currently working with the Police Department on this issue.

4. **Pool and City Park Renovations – Progress Report** (*Berman*)
 - City Park fountain removed, working on brick pavers; some work delays due to rain
 - Fumigated City Park gazebo due to termites.
 - Centennial Pool- Newton Construction discovered coping rotting around entire pool.
 - Handicap ramp/ slide needs to be recertified and reconditioned- may not open in May.
 - Municipal Pool- is progressing well.
