SUBJECT: Sherwood Dog Park Lease Extension

DATE: August 16, 2016

Needs:

For the City Council to consider authorizing a 5-year extension to the City's lease agreement with Parks 4 Pups to operate the Sherwood Dog Park at 290 Scott Street.

Facts:

- 1. On November 1, 2011, the City Council approved the interim use by Parks 4 Pups of the open lot adjacent to the Paso Robles Senior Center to develop and operate a dog park and entered into a Lease Agreement.
- 2. The Sherwood Park Master Plan, developed in 2003, proposes four tennis courts, a sand volleyball court, and restrooms for this site.
- 3. Under the auspices of Parks 4 Pups, the Sherwood Dog Park Board of Directors has overseen the successful development, operation and maintenance of the dog park at no cost to the City.
- 4. In 2015, the Sherwood Dog Park was open to the public every day of the year, exceeding lease requirements and serving at least 100 dogs and their owners each day.
- 5. The initial term of the Lease Agreement expires as of 11:59 p.m. on February 1, 2017. The tenant has an option to extend the term for five years if the City Council determines that it does not have an immediate need for the Property to develop in accordance with the Sherwood Park Master Plan. On additional five-year option would remain if, at that time, the City Council makes a similar determination that the Property is not immediately needed. In addition, the Lease provides that either party may terminate the Lease upon two years' prior written notice to the other party.
- 6. On August 3, 2016, the City received a written request from the Sherwood Dog Park Board of Directors to exercise its option to extend the lease term to February 1, 2022.

Analysis and

Conclusion: The Sherwood Dog Park has successfully operated for nearly 5 years at 290 Scott Street under Lease Agreement with the City. The Sherwood Park Master Plan proposes the eventual conversion of this property into 4 tennis courts, a sand volleyball court and restrooms, but such conversion is not proposed for several years. The current lease is consistent with other non-profits using City property to provide community amenities, and is set to expire as of February 1, 2017. The Sherwood Dog Park Board of Directors wishes to exercise its option to extend the lease term by five years.

FIRST AMENDMENT TO LEASE

This First Amendment ("First Amendment") is entered into as of ______, 2016, by and between the City of El Paso de Robles ("Landlord") and San Luis Obispo Parks, Open Space & Trails Foundation (commonly known as SLOPOST), a California nonprofit public benefit corporation, acting through its project committee PARKS 4 PUPS (collectively referred to herein as "Lessee"), dated February 2, 2012. Landlord and Lessee may be referred to herein this First Amendment individually as a "Party" or collectively as the "Parties."

RECITALS

- A. Landlord and Lessee entered into a Lease Agreement, dated February 2, 2012, (the "Lease") for the development, operation and maintenance of an off-leash dog park on certain property (the "Property") owned by the City as an interim use.
- B. The initial term of the lease is for five (5) years and provides that if City determines it does not have an immediate need for the Property, Lessee shall have the option to extend the term for up to two additional terms, of five(5) years each
- C. Lessee has notified Landlord that it wishes to exercise its option to extend the Lease term, and City has determined that it does not have an immediate need for the Property.

Agreement

- 1. <u>Meaning of Terms; Effective Date</u>. Except as otherwise stated in this First Amendment, all initially capitalized terms in this First Amendment will have the respective defined meanings stated in the Lease, and the terms and provisions of this First Amendment will be considered to be effective as of the date of the Effective Date of this First Amendment.
- 2. <u>Revised Lease Expiration Date; Extended Term.</u> The initial Term of the Lease is currently scheduled to expire at 11:59 p.m. on February 1, 2017. As of the Effective Date of this First Amendment, the Term of the Lease is extended by five (5) years to 11:59 p.m. on February 1, 2022.
- 3. <u>Effectiveness of Lease</u>. Except as explicitly modified by this First Amendment, all of the terms and provisions of the Lease are and remain in full force and effect.

WHEREAS, the initial term of the current lease (the "Lease") with SLOPOST will expire on February 1, 2017 unless SLOPOST exercises the first of its two five- (5) year options to extend; current lease agreement expires as of 11:59 p.m. on February 1, 2017 with an option to extend the term for up to two additional terms of five years each; and,

WHEREAS, on August 3, 2016, the City received a written request from the Sherwood Dog Park Board of Directors to exercise its option to extend the Lease term to February 1, 2022;

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE AS FOLLOWS:

<u>Section 1.</u> The City Council hereby determines that it does not have an immediate need for the Property for development in accordance with the Sherwood Park Master Plan.

<u>Section 2.</u> The City Council hereby approves the First Amendment to Lease Agreement with SLOPOST, attached hereto as Exhibit A and incorporated herein by reference, and authorizes the City Manager to execute said First Amendment.

Sherwood Dog Park 2015 Summary of Activities and Events

General Activities

The Dog Park was open every day of the year from dawn to sunset with the exception of 3 days when it was closed for cement work. On average, approximately 100 dogs visited the park each day.

Events

- February Fund raising movie showing of "**Best in Show**" at Park Cinema. J. Lohr donated and poured wine in the theatre.
- March The Park's main fund raising event, the **Dog Jog**, with Kennedy Club hosting. This event included a 2k/4k walk/jog/run, a pancake breakfast, drawings, and a dog contest (best kisser, owner-dog look alike, etc.). Approximately 130 dogs and 175 people attended. In 2016 the event was held at Vina Robles.
- March Every Tuesday at Chili's restaurant, the park received 15% of proceeds from customers who mentioned Sherwood Dog Park (Chili's Give Back Program)
- April **Parkaversary** Our annual free anniversary celebration including a chili cook-off and hot dog toss with prizes for longest catch
- June, July, August Free coffee and pastry socials monthly on Saturday mornings
- October **Howloween** Another free event including a bake sale and featuring a costume contest. Over 50 dogs participated.
