For the City Council to consider an extension of and increase to professional service contracts with Downtown Paso Robles Main Street Association, Paso Robles Chamber of Commerce, and the Paso Robles Wine Country Alliance for a variety of marketing and tourism-related services.

**ROLL CALL VOTE.** Motion was made by Councilman Gregory to approve Resolution 16-113 authorizing the City Manager to enter into professional service contracts for tourism related services at an expanded scope and cost from the previous year, as follows:

1. Authorizing downtown promotions services with Paso Robles Main Street for FY 2016/17 in the amount of \$90,000;
2. Authorizing visitor center services with the Chamber of Commerce for FY 2016/17 in the amount of \$75,000;
3. Authorizing public relations services with the Paso Robles Wine Country Alliance for FY 2016/17 in the amount of \$60,000;
4. Authorizing an additional budget appropriation of \$50,000 for the aggregate change in the modified tourism contracts.
