Subject: Adding Cory Meyer, Arborist to the City's ISA Certified Arborist List

Date: February 7, 2017

Facts

1. Chapter 10.01.040 of the City Municipal code requires that a person who provides services as an arborist in the City must be certified by the Western Chapter of the International Society of Arboriculture (ISA) and must be on a list of Certified Arborists approved by the City Council.

- 2. The purpose of the pre-approved arborist consultant list (Attachment 3) is to ensure that only ISA-certified arborists are used by applicants in addressing oak tree issues.
- 3. Cory Meyer, ISA Certificate Arborist #WE7678A, has asked to be added to the City's List of Approved Arborists to do work within the City boundaries regarding oak trees (Attachment 1).
- 4. Mr. Meyer has returned a signed statement acknowledging that he understands the conditions under which the City will accept him for approval on the List (Attachment 2).
- 5. Staff has confirmed by reviewing the ISA website that Mr. Meyer is listed as an ISA Certified Arborist. Based on the ISA Certification, Mr. Meyer is qualified to provide consulting services and to prepare arborist reports to the City pursuant to Chapter 10.01 requirements.

Analysis and Conclusion

The Oak Tree Protection Ordinance (Municipal Code Chapter 10.01) requires that an arborist consulting in the City must be certified by the ISA as qualified to determine whether an oak tree is diseased, and able to make recommendations regarding pruning, cutting, and preservation measures.

Mr. Meyer was sent a copy of the Oak Tree Protection Ordinance and Oak Tree Evaluation Criteria, and was asked to sign a statement that he had read the Ordinance and agrees to conform to the City's criteria for evaluation reports. He responded in writing, also providing his certification number and current address/telephone and e-mail information. In addition, Mr. Meyer was advised of the need to obtain a City Business License to perform work in the City.

Options

- 1. Do nothing.
- 2. Add Cory Meyer, ISA Certified Arborist to the City's list.
- 3. Amend the above options.

Analysis and Conclusions

Option 2: As described above, Mr. Meyer is qualified to be on the City's Arborist List.

Option 3: Council may wish to approve an amended version of one of the option listed above.

Fiscal Impact

There is not a fiscal impact to the City related to adding an Arborist to the list; however, ensuring that qualified professionals are evaluating the oaks within the City helps protect Oak trees that can provide value to a property and be an aesthetic value to the City as a whole.

Recommendation

Option 1: Approve the addition of Cory Meyer, ISA Certified Arborist, to the City's list (Attachment 3).

I worked for the City of Atascadero for 27 years in park maintenance. During that time, I became an arborist and made decisions regarding the health and maintenance of the park and street trees. I also worked with Warren Frace and the City of Atascadero Community Development Department on native tree planting projects within the city.
