Subject:	Resolution for declaration of public nuisances relating to weed abatement and setting a public hearing for 2017 weed abatement.
Date:	August 1, 2017

Facts

- 1. City and State Codes require property owners to maintain their property in a fire safe condition.
- 2. Each year, Emergency Services notifies residents and property owners of the need to clear all weeds from their property by June 1st.
- 3. After June 1st, Emergency Services conducts a City wide survey collecting the addresses or parcel numbers of properties in violation of Paso Robles Municipal Code 9.06 (Nuisance Abatement).
- 4. Property owners of record per the County Assessor, who are not in compliance are individually notified of the condition and need to abate. "Notice of Nuisance" letters (sent certified mail) are mailed within the first three weeks of June and owners are given 30 days to comply.
- 5. As of the week of July 17, those properties listed in Exhibit A, have failed to comply with the public nuisance ordinance.

Options

- 1. Take no action.
- Adopt Resolution No. 17XXX making declaration of public nuisances relating to weed abatement within the City for those properties found in Exhibit A; direct the superintendent to post the property with a "Notice to Abate" and provide written notice to the property owners of each property identified in Exhibit A of a public hearing scheduled for September 7th, 2017 providing opportunity to show cause why such condition should not be condemned as a nuisance.
- 3. Amend or modify the Resolution as submitted.
- 4. Reject the Resolution in its entirety.

Analysis and Conclusions

Through its delegated authority, Emergency Services works to eliminate community fire hazards created by dry vegetation (weeds). This work includes a public information campaign, early warning letters to recalcitrant property owners, registered letters to property owners found in violation, and administrative cautions.

Emergency Services has made reasonable attempts to achieve safety regulation compliance for those properties found in Exhibit "A." These nonetheless remain in violation. Elimination of the hazard necessitates City Council declare these properties as nuisances, conduct public hearings, and name the Interim Battalion Chief as the enforcement superintendent prior to directing the work to be done.

Costs associated with the City-ordered work will be recouped via direct invoice or through special assessment lien on the negligent properties (if necessary).

Fiscal Impact

None for this action, other than staff time to post the notices, etc. and to publish the public hearing notice hearing.

Recommendation

Approve Resolution 17-XXX declaring the properties described in Exhibit A as public nuisances in violation of Paso Robles Municipal Code 9.06; direct the superintendent to post the property with a "Notice to Abate" and provide written notice to the property owners of each property identified in Exhibit A of a public hearing to be scheduled for September 7th, 2017.

RESOLUTION NO. 17-XXX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES MAKING DECLARATION OF PUBLIC NUISANCES RELATING TO WEED ABATEMENT WITHIN THE CITY AND SETTING PUBLIC HEARING FOR 2017 WEED ABATEMENT

WHEREAS, the Govt. Code 39560, et seq., provides a procedure by which a City may declare weeds and other noxious growths on private property as a public nuisance for abatement purposes; and

WHEREAS, the Govt. Code 39561.5 defines weeds for the purposes of this abatement as follows;

- (a.) Weeds which bear seeds of a downy or wingy nature.
- (b.) Sagebrush, Chaparral, or any other brush or weeds which may attain such a large growth as become, when dry, a fire menace to adjacent improved property.
- (c.) Weeds which are otherwise noxious or dangerous.
- (d.) Poison oak and poison ivy when conditions of the growth are such as to constitute a menace to public health.
- (e.) Dry grass, stubble, brush, litter or other flammable material which endangers the public safety by creating a fire hazard; and

WHEREAS, Govt. Code 39560 provides that the City Council must designate a "superintendent" for purpose for enforcement of this action.

WHEREAS, Paso Robles Municipal Code 9.06 (Nuisance Abatement) prescribes the steps necessary to declare and abate conditions of public nuisance; and

WHEREAS, through its delegated authority, Emergency Services has worked to eliminate community fire hazards created by dry vegetation (weeds), including a public information campaign, early warning letters to recalcitrant property owners, registered letters to property owners found in violation, and administrative cautions; and

WHEREAS, Emergency Services has made reasonable attempts to achieve safety regulation compliance for those properties found in Exhibit "A," but they nonetheless remain in violation.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE AS FOLLOWS:

<u>Section 1</u>. All of the above recitals are true and correct and incorporated herein by reference.

<u>Section 2.</u> Based on the information contained in the staff report, dated August 1, 2017 , testimony presented during the public hearing, and responses thereto, the City Council hereby finds and determines that:

- a. For the purposes of the 2017 Weed Abatement program, the superintendent is Richard Gallagher, Emergency Services Interim Battalion Chief.
- b. The weeds or noxious growths growing on the properties identified in Exhibit "A" are hereby declared to be a nuisance.
- c. The Interim Battalion Chief is hereby directed to post the property with the "Notice To Abate" and give written notice to the property owners of each property identified in Exhibit "A" of a public hearing scheduled for September 7th, 2017 at 6:30 p.m. at the regular El Paso de Robles City Council meeting for hearing of all objections re the City's' action to declare public nuisance.
