Subject: Acceptance of Office of Traffic Safety (OTS) State Grant to Purchase Traffic Safety

Equipment and Fund Overtime Expenses for Traffic Enforcement

Date: August 15, 2017

Facts

- 1. The City of Paso Robles Police Department applied for and has been selected to receive \$90,000 in FY 2017-18 from the State of California Office of Traffic Safety Grant.
- 2. This grant does not require matching funds from the City of Paso Robles.
- 3. City Council notification and acceptance is requested for the Police Department to secure this grant. This will be accomplished at the regularly scheduled Council meeting through review of this staff report, where public comment will be invited.
- 4. The Police Department intends to use the OTS grant funds as designated in the grant agreement. This includes the purchase of Driving Under the Influence (DUI) checkpoint supplies and speed detection equipment. In addition, the grant agreement provides overtime funding for DUI, bicycle, pedestrian, seatbelt and distracted driving enforcement.

Options

- 1. Do not accept the grant.
- 2. Adopt Resolution No. 17-xxx accepting the Office of Traffic Safety Grant of \$90,000 to Fund 1002110-46170-PD006, and expensing a total of \$90,000 between accounts 1002110-54540-PD006, 1002110-52260-PD006 and 1002110-51030-PD006 and approving the outlined expenditure plan.

Analysis and Conclusions

- 1. If we do not accept the grant, we will not be taking a proactive stance to protect the community from collisions related to alcohol and other primary collision factors.
- 2. If we accept the grant, we will be implementing best practice strategies to reduce the number of persons killed or injured in crashes involving alcohol and other primary collision factors.

Fiscal Impact

None. The funding is coming from the State of California – Office of Traffic Safety Grant that will be placed into the City's Police Department Grant Fund and may only be used for the purposes as described in the grant agreement document.

Recommendation

Authorize the City Manager to execute all necessary documents to accept the State of California – Office of Traffic Safety Grant implementing best practice strategies to reduce the number of persons killed or injured in crashes involving alcohol and other primary collision factors

WHEREAS, the City of El Paso de Robles Police Department is eligible for funds up to \$90,000 from the State of California - Office of Traffic Safety Grant; and

WHEREAS, the State of California - Office of Traffic Safety administrator has notified the City of a \$90,000 maximum award to be received by the City of El Paso de Robles in fiscal year 2017-18; and

WHEREAS, the monies received from the State of California – Office of Traffic Safety Grant are for the purpose of implementing best practice strategies to reduce the number of persons killed or injured in crashes involving alcohol and other primary collision factors; and

WHEREAS, with the acceptance of the above described grant funds, the Police Department plans to purchase equipment and fund patrol overtime as designated in the grant agreement.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The City Council of the City of El Paso de Robles does authorize the City Manager to execute all documents necessary to accept the State of California - Office of Traffic Safety Grant in the amount of \$90,000 (maximum).

Section 2. The City Council approves a one-time budget appropriation in the total amount of \$90,000 between the General Fund budget accounts 1002110-54540-PD006, 1002110-52260-PD006 and 1002110-51030-PD006 to fund purchases and overtime identified in the expenditure plan with an offsetting revenue budget adjustment in the same amount to revenue account 1002110-46170-PD006. Funding of this expense will be through the State of California - Office of Traffic Safety Grant.

1. PROBLEM STATEMENT

The City of Paso Robles was incorporated in 1889. The City is approximately 20 square miles with a population of approximately 31,500. The Paso Robles Police Department is currently comprised of 34 sworn officers which includes a Chief, two Lieutenants, six Sergeants and twenty-four Officers.

In 2002, the city was designated an urban area from its previous rural designation, and it is emerging as a new 'wine region' with over 200 wineries. The city hosts several community events throughout the year that draw thousands of visitors to the area. These events include the California Mid State Fair, Zinfandel Festival, Wine Country Half Marathon, Paso Robles Wine Festival, Festival of the Arts, Firestone Walker International Brewfest, Paso Robles Classic Car Weekend, California Wine Month and Pioneer Day. Many of these events have alcohol service as an integral part of the attraction. The California Mid State Fair runs for twelve days and causes a tremendous impact on the city services by bringing approximately 410,000 attendees to the city annually. The city is also the primary access point for Lake Nacimiento, an area popular with tourists, which attracts drivers from throughout the region.

Due to low staffing, the Paso Robles Police Department took multiple years off from applying for grants and even suspended the traffic officer position. In 2016, the budget and Departmental personnel began to rise and the Department was able to re-establish the Traffic Division with one full-time motor officer, in addition to four police officer recruits. This is a testament to the City of Paso Robles Police Department's dedication to traffic safety.

In reviewing our collision and DUI stats from 2013, the city had 237 reported collisions, with 55% of the collisions resulting in injuries. That same year, 2013, the Department arrested 182 DUI drivers. The following year in 2014, the city had 465 collisions with 21% of the collisions resulting in injuries. 218 DUI arrests were made that year. In 2015, Paso Robles Police Department had 553 total collisions with 29% of the collisions resulting in injuries. A total of 161 arrests were made for DUI drivers in 2015. The Paso Robles Police Department has continuously taken a strong stance against drivers who operate vehicles while intoxicated, exemplified by a combined 561 total DUI arrests within the listed 3-year period.

When evaluating the total collision percentage rates from the year 2013-2014 the city experienced a rise of 96% more traffic collisions, compared to 2014-2015 where there was an 18% rise in traffic collisions. After the introduction of a Paso Robles Police Department Motor Officer position in 2016 the city experienced a 10% decrease in total traffic collisions from 2015 to 2016.

METHOD OF PROCEDURE

A. Phase 1 - Program Preparation (1st Quarter of Grant Year)

- The police department will develop operational plans to implement the "best practice" strategies outlined in the objectives section.
- All training needed to implement the program should be conducted this quarter.
- All grant related purchases needed to implement the program should be made this quarter.
- In order to develop/maintain the "Hot Sheets," research will be conducted to identify the "worst of the worst" repeat DUI offenders with a suspended or revoked license as a result of DUI convictions. The Hot Sheets may include the driver's name, last known address, DOB, description, current license status, and the number of times suspended or revoked for DUI. Hot Sheets should be updated and distributed to traffic and patrol officers at least monthly.

- Implementation of the STEP grant activities will be accomplished by deploying personnel at high collision locations. Media Requirements
- Issue a press release announcing the kick-off of the grant by November 15. The kick-off press releases and media advisories, alerts, and materials must be emailed to the OTS Public Information Officer at pio@ots.ca.gov, and copied to your OTS Coordinator, for approval 14 days prior to the issuance date of the release.

B. Phase 2 – Program Operations (Throughout Grant Year)

- The police department will work to create media opportunities throughout the grant period to call attention to the innovative program strategies and outcomes. Media Requirements
- Send all grant-related activity press releases, media advisories, alerts and general public materials to the OTS Public Information Officer (PIO) at pio@ots.ca.gov, with a copy to your OTS Coordinator.
 - If an OTS template-based press release is used, the OTS PIO and Coordinator should be copied when the release is distributed to the press. If an OTS template is not used, or is substantially changed, a draft press release shall be sent to the OTS PIO for approval. Optimum lead time would be 10-20 days prior to the release date to ensure adequate turn-around time.
 - Press releases reporting the results of grant activities such as enforcement operations are exempt from the recommended advance approval process, but still should be copied to the OTS PIO and Coordinator when the release is distributed to the press.
 - Activities such as warrant or probation sweeps and court stings that could be compromised by advanced publicity are exempt from pre-publicity, but are encouraged to offer embargoed media coverage and to report the results.
- Use the following standard language in all press, media, and printed materials: Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
- Email the OTS PIO at pio@ots.ca.gov and copy your OTS Coordinator at least 30 days in advance, a short description of any significant grant-related traffic safety event or program so OTS has sufficient notice to arrange for attendance and/or participation in the event.
- Submit a draft or rough-cut of all printed or recorded material (brochures, posters, scripts, artwork, trailer graphics, etc.) to the OTS PIO at pio@ots.ca.gov and copy your OTS Coordinator for approval 14 days prior to the production or duplication.
- Include the OTS logo, space permitting, on grant-funded print materials; consult your OTS Coordinator for specifics.

C. Phase 3 – Data Collection & Reporting (Throughout Grant Year)

- Invoice Claims (due January 30, April 30, July 30, and October 30)
- Quarterly Performance Reports (due January 30, April 30, July 30, and October 30)
 - Collect and report quarterly, appropriate data that supports the progress of goals and objectives.
 - Provide a brief list of activity conducted, procurement of grant-funded items, and significant media activities. Include status of grant-funded personnel, status of contracts, challenges, or special accomplishments.
 - Provide a brief summary of quarterly accomplishments and explanations for objectives not completed or plans for upcoming activities.
 - Collect, analyze and report statistical data relating to the grant goals and objectives.

3. METHOD OF EVALUATION

Using the data compiled during the grant, the Grant Director will complete the "Final Evaluation" section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant's accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

4. ADMINISTRATIVE SUPPORT

This program has full administrative support, and every effort will be made to continue the grant activities after grant conclusion.
