Subject: Senior Citizen Advisory Committee Appointment

Facts

- 1. On April 26, 2017, City Council conducted interviews and made five appointments to the Senior Citizen Advisory Committee.
- 2. One vacancy remains on the Senior Citizen Advisory Committee; there was not an application to fill this vacant position until recently. Paul Nevosh, a Paso Robles resident, recently submitted an application to fill this vacancy.
- 3. Mr. Nevosh has attended several consecutive Senior Citizen Advisory Committee meetings since July of this year and has been introduced to the City Council liaisons to this committee.

Options

- 1. Take no action.
- Appoint Paul Nevosh to a 2-year term on the Senior Citizen Advisory Committee, effective immediately.
- 3. Provide alternative direction to staff.

Analysis and Conclusions

There is a need for an additional representative on the Paso Robles Senior Citizen Advisory Committee. Paul Nevosh submitted an application for the Senior Citizen Advisory Committee indicating that he meets the requirements for this position.

Recommendation

Appoint Paul Nevosh to a 2-year term on the Paso Robles Senior Citizen Advisory Committee, effective immediately.
