Subject: Appointment of Richard McKinley as Acting City Manager, to Serve When the City Manager

is Unable to Be Reached or Is Incapacitated

Date: December 19, 2017

Facts

1. The City Manager is the Chief Executive Officer of the City and, as such, has certain mandated duties, including authorizing purchases, directing staff, negotiating and executing agreements, etc.

- 2. In addition, the City Manager serves as the Director of Emergency Services in the event of a natural or man-made disaster or other emergency event.
- 3. As such, there exists the need for a back-up when the City Manager is not available or is incapacitated.
- 4. The Assistant City Manager is directed by the Paso Robles Municipal Code to serve as the Assistant Director of Emergency Services. In addition, the Assistant City Manager serves as the Acting City Manager when the City Manager cannot be reached or is incapacitated.
- 5. Upon the retirement of Meg Williamson as Assistant City Manager on December 29, and until the appointment of a replacement Assistant City Manager, there is no person in the City service who automatically fills these roles.

Options

- 1. Take no action:
- 2. Confirm the appointment of Dick McKinley as Acting City Manager in the event the City Manager cannot be reached or is unable to serve;
- 3. Provide alternative direction to staff;

Analysis and Conclusions

Given his broad experience in municipal matters, his knowledge of the community, as well as his role as Public Works Director, Dick McKinley is highly qualified to fill in during the absence of the City Manager as the Acting City Manager and as the Assistant Emergency Services Director.

It is necessary and appropriate to make this appointment now, to ensure a smooth assumption of duties if needed and to provide Mr. McKinley the opportunity to participate in emergency preparedness drills in this role.

Recommendation

Confirm the appointment of Dick McKinley as Acting City Manager in the event the City Manager cannot be reached or is unable to serve, effective upon the retirement of Meg Williamson as Assistant City Manager, on December 29, 2017, and continuing until the appointment of a replacement Assistant City Manager.
