**ROLL CALL VOTE #1.** Motioned by Councilman Gregory, seconded by Councilman Strong, and passed 4-1 (Councilman Reed objecting) to adopt the Preferred Alternative Design for Creston Road as presented with the change discussed by Councilmember Hamon to narrow the median (center turn lanes) to 10 feet to provide for 12-foot travel lanes.
