(It is expected that the City will have \$398,378 in CDBG funds available for activities in 2004—\$320,378 available for projects and programs and \$78,000 for program administration. The City has 22 applications for funding, totaling over \$991,057.)

2. 2004 Consolidated Plan and Federal HOME and Emergency Shelter Grant (ESG) Programs

Consider recommending to the County Board of Supervisors those activities to be approved for funding with the County's 2004 allotments of Federal Home Investment Partnership Act (HOME) and Emergency Shelter Grant (ESG) funds. (HOME and ESG funds are federal funds allocated annually by the Department of Housing and Urban Development [HUD]. Federal regulations governing these funds require a Consolidated Plan, one part of which is the "Annual Action Plan," which is adopted annually. The Draft Annual Action Plan proposes award of \$19,952 in 2004 ESG funds to the North County Women's Resources Center. The remaining \$74,000 in ESG funds are proposed to be allocated to homeless facilities located in the South County.)
