

MINUTES OF THE SPECIAL MEETING

DECEMBER 22, 1983

The City Council of the City of El Paso de Robles, meeting in special session on the above date, was called to order by Mayor Gary Stemper at 4:30 p.m. in the City Council Chambers with the following Councilmen answering roll call: Monroe, Ovitt, Russell, Thorndyke and Stemper; none being absent.

1. Upon motion by Councilman Ovitt, seconded by Councilman Monroe and passed unanimously the meeting was adjourned to a closed session for personnel matters.
2. After the closed session, the Mayor called the meeting back to order and stated that City Manager, Richard W. Deming, had an announcement to make.
3. City Manager, Richard W. Deming, announced that he has resigned as City Manager from the City of Paso Robles, effective January 2, 1984, stating that the City Council and he had a difference of opinion on City goals and overall philosophy.
4. Motion by Councilman Russell, seconded by Councilman Thorndyke and passed unanimously to accept the resignation of Richard W. Deming effective January 2, 1984, and authorize the Mayor and City Clerk to sign said resignation.
5. There being no further business, upon motion by Councilman Russell, seconded by Councilman Ovitt and passed unanimously the meeting was adjourned.
