# CALL TO ORDER – Library/City Hall Conference Center

The City Council of the City of El Paso de Robles, meeting in regular session at 7:30 PM on the above date in the Library/City Hall Conference Center, was called to order by Mayor Frank Mecham.

# PLEDGE OF ALLEGIANCE

### PUBLIC COMMENTS

- Pat Mackie questioned the reaction of other mayors to the opinion letter Mayor Mecham wrote in response to the mayors' letter of San Luis Obispo County opposing the Navy bombing proposal at Stoney Valley, Fort Hunter Liggett.
- Dale Gustin announced that the annual senior picnic *Senior Fiesta* would be held at Centennial Park on Saturday, May 12<sup>th</sup>, beginning at 11:00 a.m. Senor Sancho's will cater the event at \$6.00 per plate.
- Lisa Kamekona, a para-educator at the Paso Robles High School, petitioned Council for support and direction to help with travel expenses to send student David Reyes to Washington, D.C., where his art will be on display in the Capitol Building.

### DISCUSSION

1. Consider Appealing County Subdivision Review Board Action Regarding Environmental Document, Lot Line Adjustment and Development Plan for Santa Ysabel Ranch

Consider whether or not to appeal the approval of the County Subdivision Review Board regarding the environmental document, lot line adjustment and development plan for the Santa Ysabel Ranch development project.

Mayor Mecham opened the public hearing. Speaking from the public were Mike Toohey (applicant representative), Dale Gustin, Pat Mackie, Tom Rusch, Judith Baron, Peggy McGonagill, Susan Harvey, Steven Long, and Tim Cleath and John Kammer (applicant representatives/consultants). There being no further comments either written or oral, the public discussion was closed.

Council identified the specific areas of concern they believe have not been adequately addressed by the County Board of Supervisors: (1) adequacy and relevancy of air quality mitigation measures; (2) adequacy of cumulative traffic impact mitigation; and (3) adequacy of oak tree related mitigation measures. Councilmember Nemeth, seconded by Councilmember Heggarty, moved to direct staff to file an appeal on the County Subdivision Review Board action relative to the environmental determination for the subject project.
