Mike Menath pointed out a typographical error in Item No. 6 of the Housing Authority minutes: In the second paragraph, the wording *broken noise* should be corrected to read *broken noses*.

8. Adopt Resolution No. 01-256 awarding design services contract to Sawyer, Inc. to rehabilitate the Municipal Bath House for a not-to-exceed fee of \$19,400. (On October 16th, staff issued a Request for Proposals to twelve local architects to perform architectural design services to assist staff on this project. The City received only one response from Sawyer, Inc. of Santa Margarita.)

9. Request to Remove Oak Trees - Blackburn Street

R. Lata, Community Development Director

Consider a request to remove three oak trees—a 12-inch diameter tree, a 8-inch diameter tree, and a 8-inch diameter double trunk tree. (Plans have been submitted to the City to construct Blackburn Street, east of Leland Street, in order to satisfy Municipal Code requirements of providing street improvements adjacent to property proposed for development. Staff is proposing realignment of the roadway because of potential impacts to one of the larger and healthier oak trees located in this area. Realignment would necessitate the removal of the three oak trees.) ITEM CONTINUED FROM NOVEMBER 20TH COUNCIL MEETING.

Mayor Mecham opened the public hearing. Speaking from the public were Tim Roberts (representing all involved parties--Bill Ridino, Gary Mulholland and Dennis Sullivan), Jack Brazeal, Michael Kane and Bill Ridino. There being no further comments either written or oral, the public discussion was closed.

Councilmember Picanco, seconded by Councilmember Finigan, moved to adopt Resolution No. 01-257 authorizing the removal of one 8-inch diameter double trunk oak (Tree No. 6), one 12-inch diameter oak (Tree No. 7), and one 8-inch diameter oak (Tree No. 8) in order to minimize impacts to a 14-inch diameter oak (Tree No. 12); and requiring two (2) replacement oak trees conforming to Section 10.01.040 (E) of the Municipal Code for each tree removed, either on the subject parcel, or elsewhere in the City, at the direction of the Street Superintendent. Said replacement oak trees shall be planted or furnished to the City prior to issuance of an encroachment permit to construct the Blackburn Street improvements. Additionally, the applicant shall design Blackburn Street along an alignment shifted away from Tree No. 12, the separation of which shall be recommended by a certified arborist. 10. Request to Remove Oak Tree - 1403 Stoney Creek Road

Consider a request to remove a 58-inch diameter oak tree at 1403 Stoney Creek Road. (Original request from Creston Courtyard Homeowners Association to trim this oak culminated in a report warning that the tree was unstable. That, coupled with the extensive branch removal which would be required to ensure safety, would leave little of the tree remaining.)

Mayor Mecham opened the public hearing. Speaking from the public were Melvin Hooper and Jack Brazeal. There being no further comments either written or oral, the public discussion was closed.

Councilmember Picanco, seconded by Councilmember Heggarty, moved to adopt Resolution No. 01-258 authorizing trimming of a 58-inch oak tree at 1403 Stoney Creek Road. Trimming shall be under supervision of a certified arborist and shall include 25 to 50 percent of the tree canopy (the exact extent to be determined by the arborist) in a manner designed to maximize public safety and ensure the health of the tree. Consider adoption of resolutions designating the intersections of Buena Vista Drive/River Oaks Drive/Dallons Drive and River Oaks Drive/Clubhouse Drive as all-way stop intersections (The addition of stop signs at these two intersections will provide for controlled crossing for students attending both Cuesta College and Kermit King Elementary School.)
