AN ORDINANCE AMENDING ORDINANCE NO. 105 N.S.


The City Council of the City of El Paso de Robles does ordain as follows:

That Ordinance No. 105 N. S. entitled "AN ORDINANCE DIVIDING THE CITY OF EL PASO DE ROBLES INTO DISTRICTS OR ZONES FOR THE PURPOSE OF REGULATING THE USE OF LANDS IN SAID DISTRICTS OR ZONES, THE USE, SIZE AND LOCATION OF BUILDINGS OR OTHER IMPROVEMENTS THEREIN: THE LOCATION OF TRADE, BUSINESS, AND INDUSTRIES THEREIN: AND SPECIFYING AND DESCRIBING THE AREAS INCLUDED WITHIN THE VARIOUS ZONES AND DISTRICTS AND PRESCRIBING AND LIMITING THE USE OF LANDS AND THE USE, SIZE AND LOCATION OF BUILDINGS AND IMPROVEMENTS IN THE VARIOUS ZONES AND DISTRICTS AND ESTABLISHING CERTAIN SET-BACK LINES IN THE CITY OF EL PASO DE ROBLES AND PRESCRIBING CERTAIN GENERAL PROVISIONS AND EXCEPTIONS GOVERNING THE ENFORCEMENT AND APPLICATION OF THE ORDINANCE, AND SPECIFYING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE AND ESTABLISHING A PROCEDURE FOR THE AMENDMENT AND MODIFICATION THEREOF", passed on the 20th day of September, 1943, be, and the same is hereby, amended by changing the hereinafter described district from an R-3 District to an M-1 District.

SECTION 1. That district or parcel of land situate in the city of El Paso de Robles and described as follows, to wit: From the center line of 22nd Street North to the center line of 26th Street and from the center line of Park Street East to the Southern Pacific Railroad and all land and lots included within said boundaries shall hereinafter be designated and subject to the restrictions of an M-1 District as described in Ordinance 105 N. S. and shall no longer be designated or subject to the restrictions of a R-3 District as described in said ordinance.

PASSED AND ADOPTED by the City Council of the City of El Paso de Robles this 6th day of May, 1946.
