AN ORDINANCE AMENDING SECTION II OF ORDINANCE NO. 53 N. S.
 AND REPEALING ORDINANCE NO. 109 N. S.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES
 DOES ORDAIN AS FOLLOWS:

That Ordinance 109 N. S., entitled "AN ORDINANCE AMENDING SECTION II OF ORDINANCE 53 N. S.", passed on the 7th day of August, 1944, is hereby repealed, and that Section II of Ordinance 53 N. S., entitled "AN ORDINANCE MAKING CERTAIN STREETS BOULEVARDS AND REPEALING ORDINANCE NO. 32 N. S. AND ORDINANCE NO. 40 N. S.", passed on the 2nd day of October, 1933, be and the same is hereby amended to read as follows:

SECTION II. The following streets are hereby declared to be and constitute boulevards for the purpose of this Ordinance, to-wit:

The whole of Spring Street: Oak Street from the Southerly line of 13th Street to the Northerly line of 24th Street; Park Street from the Southerly line of 13th Street to the Northerly line of 21st Street; 24th Street from the Westerly line of Spring Street to the Westerly line of Vine Street, and 13th Street from the Easterly line of Spring Street to the Easterly line of Salinas Street; Vine Street from the Southerly line of 12th Street to the Northerly line of 24th Street; 12th Street from the Easterly line of Pine Street to the Westerly line of Chestnut Street; 15th Street at the intersection of Chestnut Street and 15th Street.


This act is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety, within the meaning of Section 1, of Article IV, of the Constitution, and shall therefore go into immediate effect. The facts constituting the necessity are as follows:

That the said intersection of Chestnut Street at 15th Street constitutes a grave hazard to pedestrians and motorists and is of such a nature as to require immediate correction in

order to avoid serious and destructive accidents.


