AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES REGULATING THE ERECTION, CONSTRUCTION, MOVING AND OCCUPANCY OF ANY BUILDING OR DWELLING HOUSE WITHIN 500 FEET OF ANY SEWAGE DISPOSAL PLANT LOCATED IN THE CITY OF EL PASO DE ROBLES AND REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES ORDAIN AS FOLLOWS:

SECTION 1: For the purpose of maintaining the health and well-being of the residents of the City of El Paso de Robles, and for that purpose it shall be unlawful for any person to construct any dwelling house or any other building wherein people dwell within the City of El Paso de Robles within Five Hundred (500) feet of any sewage disposal plant located within the limits of the City of El Paso de Robles or within Five Hundred (500) feet of any plant wherein sewage is deposited, treated or disposed of.

SECTION 2: It shall be unlawful for any person to build any building wherein any person carries on any trade or occupation within the City of El Paso de Robles within Five Hundred (500) feet of any sewage disposal plant located within the limits of the City of El Paso de Robles or within Five Hundred (500) feet of any plant wherein sewage is deposited, treated or disposed of.

SECTION 3: No permit shall be issued by the City Building Inspector or any other person for the erection of said dwelling or other building within said limits.
