

ORDINANCE NO. 150 N. S.

AN ORDINANCE AMENDING ORDINANCE NO. 138 N. S.

The City Council of the City of El Paso de Robles does ordain as follows:


SECTION I: That Section 3 of Ordinance No. 138 N. S., entitled "AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES REGULATING THE ERECTION, CONSTRUCTION, ENLARGEMENT, ALTERATION, REPAIR, MOVING, REMOVAL, DEMOLITION, CONVERSION, OCCUPANCY, EQUIPMENT, USE, HEIGHT, AREA AND MAINTENANCE OF ALL BUILDINGS AND/OR STRUCTURES IN THE CITY OF EL PASO DE ROBLES; PROVIDING FOR THE ISSUANCE OF PERMITS AND COLLECTION OF FEES THEREFORE; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; DECLARING AND ESTABLISHING FIRE ZONES, REPEALING ORDINANCE NO. 116 N. S. AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH" passed on the 18th day of April, 1949, is hereby amended to read as follows:

Section 3: That the entire incorporated area of the City of El Paso de Robles is hereby declared to be and is hereby established as a Fire District and said fire district shall be known and designated as Fire Zones 1, 2 and 3, and each such zone shall include such territory or portions of said city as illustrated, outlined and designated on a certain map on file in the office of the City Clerk of the City of El Paso de Robles, being marked and designated as "Map No. 2 of Fire Zones of the City of El Paso de Robles, dated August 21, 1950", which is hereby adopted as the fire zoning map of the City of El Paso de Robles for the application of the regulations included in the "Uniform Building Code, 1949 Edition, published by the Pacific

Coast Building Officials Conference."


