

ORDINANCE NO. 181 N.S.

AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES AMENDING
ORDINANCE NO. 87 N.S.

The Council of the City of El Paso de Robles do
ordain as follows:

SECTION 1: That Section $4\frac{1}{2}$ be added to Ordinance
No. 87 N.S., as follows:

SECTION $4\frac{1}{2}$ (a) Because of the public service nature
of the taxicab business, each owner of a permit to operate
one or more taxicabs in this city shall furnish twenty-four
(24) hour daily service, Sundays and holidays included.

(b) The failure of any owner or permit holder to
comply with Section $4\frac{1}{2}$ (a), above, for a period of thirty (30)
days shall be reported by the Chief of Police of the City of
El Paso de Robles to the City Council, and upon receiving such
report the City Council may take steps as provided in Ordinance
87 N.S. to cancel the permit or permits.

(c) In the event any permit or permits to operate
one or more taxicabs are canceled for failure to comply with
Section $4\frac{1}{2}$ (a), above, any business license issued by this
city to the Owner of any such permit or permits to operate a
taxicab business is automatically revoked.

SECTION 2: That Section $12\frac{1}{2}$ be added to Ordinance
No. 87, N.S., as follows:

SECTION $12\frac{1}{2}$ Each owner holding a permit to operate
one or more taxicabs shall file an annual written report not
later than June 15th of each year, and before the new annual
business licenses are issued for the year. The report shall
contain the following information:


(a) The number of his taxicabs licensed by this city
and the name of each insurance company that has written public

liability and/or property damage on each of said cabs and the date or dates of expiration of each of said policies, together with the policy number or numbers.

(b) A statement of the holder of the permit, giving the full name and address of permit-holder and, if the ownership is in the names of more than one person, the names and addresses of said persons and the proportion of ownership of each of said persons.


