

ORDINANCE NO. 201 N.S.

AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES APPROVING THE ANNEXATION TO THE CITY OF EL PASO DE ROBLES OF CERTAIN INHABITED TERRITORY DESIGNATED AS "ANNEXATION NO. 7", WHICH IS CONTIGUOUS TO THE CITY OF EL PASO DE ROBLES, UPON THE TERMS CONTAINED IN THE QUESTION SUBMITTED AT A SPECIAL ELECTION HELD IN SAID TERRITORY ON THE 22 DAY OF JANUARY, 1957.

WHEREAS, pursuant to the provisions of an Act of the Legislature of the State of California, known as the "Annexation Act of 1913", and pursuant to Resolution No. 984, adopted by the City Council of the City of El Paso de Robles on the 26th day of November, 1956, a special election was held on the 22nd day of January, 1957, in that certain inhabited territory contiguous to the City of El Paso de Robles, designated as "Annexation No. 7", and which is hereinafter more particularly described; and

WHEREAS, at said special election the following question was submitted to the qualified electors residing in said territory:

SHALL THE TERRITORY KNOWN AS "ANNEXATION NO. 7" BE ANNEXED TO, INCORPORATED IN AND MADE A PART OF THE CITY OF EL PASO DE ROBLES AND THE PROPERTY IN SUCH TERRITORY BE, AFTER SUCH ANNEXATION, SUBJECT TO TAXATION EQUALLY WITH THE PROPERTY WITHIN THE CITY OF EL PASO DE ROBLES, TO PAY THE ENTIRE BONDED INDEBTEDNESS OF THE CITY OF EL PASO DE ROBLES OUTSTANDING OR AUTHORIZED AT THE DATE OF THE FILING OF THE PETITION FOR ANNEXATION FOR THE ACQUISITION, CONSTRUCTION OR COMPLETION OF MUNICIPAL IMPROVEMENTS?

WHEREAS, it appears from the canvass of the returns of the votes cast at said special election that a majority of all votes cast in said territory on the question of said annexation and the assumption of said indebtedness upon the terms contained in the question submitted; and

WHEREAS, it appears that said special election and all proceedings relating thereto have been conducted strictly in accordance with law;

NOW, THEREFORE, the City Council of the City of El Paso de Robles does ordain as follows:

SECTION 1. That the annexation of that certain inhabited territory contiguous to the City of El Paso de Robles designated as "Annexation No. 7" be and the same hereby is approved upon the terms contained in the aforesaid question which was submitted at the special election held on the 22nd day of January, 1957. Said territory is described as follows:

That certain real property located in the County of San Luis Obispo, State of California, being that portion of Lot 13, Rancho Santa Ysabel, Records of the County of San Luis Obispo, lying between Creston Road (60 feet wide) and State Highway No. 33 (60 feet wide), together with a portion of Orchard Bungalow Tract, Records of the County of San Luis Obispo, all described as follows:

That portion of Lot 13 of the Rancho Santa Ysabel lying between Creston Road and State Highway 33, together with that portion of Associated Almond Growers Orchard Bungalow Tract, as shown on the official records in the Office of the County Recorder of San Luis Obispo County, California, and all described as follows:

Beginning at the southwest corner of Lot 1, Orchard Bungalow Tract as shown in Book 2, page 55 of Maps, Records of San Luis Obispo County; thence westerly along the northerly line of Creston road as follows:  $S85^{\circ}38'00''W$  353.25 feet to a point; thence  $N74^{\circ}24'00''W$  273.22 feet to a point; thence  $N87^{\circ}34'00''W$  247.57 feet to a point lying in the easterly line of State Highway No. 41 (60 feet wide); thence northerly along said southeasterly line as follows:  $N9^{\circ}15'00''E$  300 feet to the beginning of a curve concave southeasterly having a radius of 300 feet; thence along said curve 262 feet northeasterly to a point in the southerly line of said Highway being tangent to said curve; thence easterly along said tangent line 350 feet to the beginning of a curve concave to the northeast having a radius of 730 feet; thence easterly along said curve 360 feet more or less to the northwesterly corner of Lot 3 of said Orchard Bungalow Tract being a point in the southerly line of said Highway; thence  $S3^{\circ}56'00''W$  647.32 feet more or less to the point of beginning.

Beginning at the southwest corner of Lot 1 of said Orchard Bungalow Tract; thence northerly along the westerly line of said tract to the northwesterly corner of Lot 3 of said tract; thence northeasterly along the southeasterly line of said Highway 33 to the most northerly corner of Lot 24 of said Tract; thence east along the northerly lines of Lots 25 through 28 inclusive of said tract; thence east and south along the northerly boundary of Lot 30 to a point lying in the northeasterly line of Lot 87 produced; thence southeasterly along said northeasterly line to the most northerly corner of Lot 76; thence southeasterly along the northeasterly line of said Lot 76 to the most southerly


