

ORDINANCE NO. 203, N.S.

AN ORDINANCE PROVIDING FOR THE PROTECTION OF THE PUBLIC HEALTH AND SAFETY, AND THE EXAMINATION, REGISTRATION, LICENSING OF PERSONS ENGAGED IN THE BUSINESS OF PLUMBING, OR LABORING AT THE TRADE OF PLUMBING; REQUIRING A PERMIT FOR THE INSTALLATION OR ALTERATION OF PLUMBING AND DRAINAGE SYSTEMS; CREATING AN ADMINISTRATIVE OFFICE AND A BOARD OF PLUMBING EXAMINERS, AND PRESCRIBING THEIR DUTIES; DEFINING CERTAIN TERMS; ESTABLISHING MINIMUM REGULATIONS FOR THE ALTERATION, INSTALLATION OR REPAIR OF PLUMBING AND DRAINAGE SYSTEMS AND THE INSPECTION THEREOF; PROVIDING PENALTIES FOR ITS VIOLATION AND REPEALING CONFLICTING ORDINANCES.


The City Council of the City of El Paso de Robles does ordain as follows:

SECTION I. That a certain document, three (3) copies of which are on file in the office of the City Clerk of the City of El Paso de Robles, being marked and designated as "Uniform Plumbing Code, 1955 Edition", published by Western Plumbing Officials Association, be and the same is hereby adopted as the plumbing code of the City of El Paso de Robles for the protection of the public health and safety, and the examination, registration, licensing of persons engaged in the business of plumbing, or laboring at the trade of plumbing, or of requiring for permit for the installation or alteration of plumbing, gas, and drainage systems; creating the office of Plumbing Inspector and a Board of Plumbing Examiners, and prescribing their duties; defining certain terms; establishing minimum regulations for the installation, alteration or repair of plumbing, gas, and drainage systems and the inspection thereof and providing penalties for its violation, and each and all of the regulations, provisions, penalties, and conditions, and terms of such "Uniform Plumbing Code, 1955 Edition", published by the Western Plumbing Officials Association, on file in the office of the City Clerk of the City of El Paso de Robles, are hereby referred to, adopted and made a part hereof as if fully set out in this ordinance.

SECTION II. In addition to complying with the terms as required by said "Uniform Plumbing Code" and before any person shall perform any plumbing work within the City of El Paso de Robles, or be entitled to a license as a plumber he shall first file with the City Council a bond issued by an authorized surety company in the sum of Five Hundred Dollars (\$500.00), said bond to be conditioned for the faithful performance of his work in accordance with the provisions of said "Uniform Plumbing Code."

SECTION III. That Ordinance No. 154, N.S. entitled, "An Ordinance PROVIDING for the Protection of the Public Safety and the Registration, Licensing, of Persons Engaged in the Business of Plumbing or Laboring at the Trade of Plumbing; Requiring a Permit for the Installation or Alteration of Plumbing, Gas and Drainage Systems; Creating the Office of Plumbing Official and Prescribing his Duties; Defining Certain Terms; Establishing Minimum Regulations for the Installation, Alteration or Repair of Plumbing, Gas, and Drainage Systems and the Inspection Thereof; Providing for the Posting of a Bond Before any License to a Plumber is Issued, or any Plumbing Work is Contracted for; and Providing Penalties for its Violation, and Repealing Conflicting Ordinances", passed on the 18th day of December, 1950, and all other Ordinances and parts of Ordinances in conflict herewith are hereby repealed.
