

ORDINANCE NO. 347 N.S.

AN ORDINANCE APPROVING THE ANNEXATION OF CERTAIN INHABITED TERRITORY, DESIGNATED, "CRESTON ROAD-GOLDEN HILL ROAD ANNEXATION, ANNEXATION NO. 24", TO THE CITY OF EL PASO DE ROBLES.

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES ORDAIN AS FOLLOWS:

WHEREAS, a petition having been filed with the City Council of the City of El Paso de Robles on September 18, 1972, requesting the annexation of the inhabited territory as herein set forth to the City of El Paso de Robles, and the City Council of the City of El Paso de Robles having on the 18th day of September 1972, adopted and passed Resolution No. 1682 consenting to the proposed annexation and requesting the San Luis Obispo County Local Agency Formation Commission to approve the annexation of the within described territory; and

WHEREAS, it was found that all property owners of record and all owners of any property of said land seeking to be annexed have in writing consented to said annexation; and

WHEREAS, the Local Agency Formation Commission of the County of San Luis Obispo did on March 15, 1973, unanimously approve the "Creston Road-Golden Hill Road Annexation, Annexation No. 24", to the City of El Paso de Robles, and further found that the City of El Paso de Robles be authorized to complete the annexation without further notice, hearing, or election, since all land owners involved have signified their approval in writing; and

WHEREAS, said territory is contiguous to the City of El Paso de Robles; is inhabited territory in the County of San Luis Obispo; and such annexation will not create any island of unincorporated territory; and all of the owners of an interest in the land in the territory to be annexed having consented in writing to be subject to all of the bonded indebtedness of the City of El Paso de Robles, and to pay the same tax rate in the future as levied by the City of El Paso de Robles;

NOW THEREFORE THE CITY COUNCIL of the City of El Paso de Robles does hereby approve the annexation of the territory hereinafter described and known as "Creston Road-Golden Hill Road Annexation, Annexation No. 24" to the City of El Paso de Robles, and does hereby

annex the said territory to the City of El Paso de Robles, subject to all existing bonded indebtedness of said City.

The said territory, the annexation of which to the City of El Paso de Robles is hereby approved, is all that territory situated in the County of San Luis Obispo, State of California, more particularly described in "Exhibit A" attached hereto and by this reference incorporated herein.

This Ordinance is adopted as an Emergency Ordinance to become effective immediately in order to qualify the above annexed area to participate in Sewer Assessment proceedings required to protect the health and welfare of the community.
