

ORDINANCE NO. 365 N.S.

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF EL PASO DE ROBLES PERTAINING TO PARKING RESTRICTIONS

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES
ORDAIN AS FOLLOWS:

Section 1: That Title 12, Chapter 12.38 of the Municipal Code of the City of El Paso de Robles shall be amended to add sections 12.38.060, 12.38.070, 12.38.080 and 12.38.090 as follows:

Section 12.38.060 - Citation for Violation-Procedures
Any operator or owner of a vehicle to whom a citation has been issued for a parking violation as defined in Chapters 12.32, 12.36 and 12.38.010 and 12.38.050 may within forty-eight hours of the time of the issuance of said citation, pay to the judge of the court as a penalty for and in full satisfaction of such violation the sum of two dollars (\$2.00). The failure of such owner or operator to make such payment within said forty-eight hours shall render such owner or operator subject to the penalties hereinafter provided for violation of the provisions of this chapter.

Section 12.38.070 - Penalties for Violations
Any person violating any provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punishable by a fine not exceeding five hundred dollars (\$500.00), or by imprisonment in the county jail of San Luis Obispo County for a period not exceeding six months or by both such fine and imprisonment.

Section 12.38.080 - Saving This chapter, so far consistent therewith, shall be deemed to be in addition and supplementary to, and not in conflict with nor a repeal of prior or existing ordinances of this City, but shall be an additional provision for the regulation of traffic and parking provided for herein.

Section 12.38.090 - Severability If any section, part of section, clause, or phrase of this chapter shall be held to be unconstitutional or invalid, the remaining provisions hereof shall nevertheless remain in full force and effect.

Section 2: That Title 12, Chapter 12.42, Sections 12.42.110, 12.42.120, 12.42.130, 12.42.140 and 12.42.150 of the Municipal Code of the City of El Paso de Robles are hereby repealed.
