

ORDINANCE NO. 399 N.S.

AN ORDINANCE PROVIDING FOR THE PROTECTION OF THE PUBLIC HEALTH, WELFARE AND SAFETY BY PRESCRIBING MINIMUM STANDARDS FOR THE DESIGN, CONSTRUCTION OR INSTALLATION, REPAIR OR ALTERATIONS OF SWIMMING POOLS, PUBLIC OR PRIVATE, AND EQUIPMENT RELATED THERETO; REQUIRING A PERMIT AND INSPECTION THEREFORE; PROVIDING FOR THE ADMINISTRATION AND ENFORCEMENT OF THE STANDARDS SET FORTH HEREIN; PROVIDING FOR THE QUALIFICATION AND REGISTRATION OF PERSONS ENGAGED IN THE BUSINESS OF SWIMMING POOL INSTALLATION OR ALTERATIONS OR EQUIPMENT RELATED THERETO; AND PRESCRIBING FOR PENALTIES FOR VIOLATIONS THEREOF

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES AS FOLLOWS:

SECTION I: The 1976 Uniform Swimming Pool Code of the International Association of Plumbing and Mechanical Officials, three copies of which are now on file in the Office of the City Clerk of the City of El Paso de Robles, California, is hereby adopted as the Uniform Swimming Pool Code of the City of El Paso de Robles, California, and each and every provision therein set forth, with the exception of those additions hereinafter appearing, is hereby referred to and made a part hereof for all purposes as fully as if set forth herein.

SECTION II: Violation and Penalties -

- A. Insert "\$500.00" in blank space, third line, page 3.
- B. Insert the word "County" in blank space, fourth line, page 3.
- C. Insert the word "one" in blank space, fifth line, page 3.

SECTION III: Validity - The City Council hereby declares that should any section, paragraph, sentence, or word of this ordinance or of the code hereby adopted be declared for any reason to be invalid, it is the intent of the City Council that it would have passed all other portions of this ordinance independent of the elimination herefrom or any such portions as may be declared invalid.


