

ORDINANCE NO. 415 N.S.

AN ORDINANCE AMENDING SECTIONS 5.02.050, 5.04.220, 5.04.230, 5.04.240, 5.04.250, 5.04.260, 5.04.270, 5.04.280, 5.06.030, 5.08.030, 5.12.020, 5.16.030, 5.20.030, 5.28.070 AND 5.40.130 OF THE MUNICIPAL CODE OF THE CITY OF EL PASO DE ROBLES

T H E C I T Y C O U N C I L

City of El Paso de Robles, California

The City Council of the City of El Paso de Robles does ordain as follows:

SECTION 1. That Section 5.02.050 and Ordinance 337 N.S., Section 5, is amended to read as follows:

5.02.050. Tax increase designated - Assessment for exempt businesses. A fifty percent increase in the business license shall be assessed, and in addition each business operating within the area established under Section 5.02.020 which is exempt from the general business license tax will be assessed a levy of one hundred thirty five dollars per year.

SECTION 2. That Sections 5.04.220, 5.04.230, 5.04.240, 5.04.250, 5.04.260, 5.04.270, 5.04.280, and Ordinance 223 N.S. Sections 22, 23, 24, 25, 26, 27 and 28 are amended by doubling the rates, fees and charges set forth therein.

SECTION 3. That Section 5.06.030 and Ordinance 381 N.S. Section 2 are amended to increase the rate from six percent to eight percent, during the months of May, June, July, August and September. During the balance of the year the rate shall be the average rate of the county and all cities within the county rounded to the nearest full percentage point or the existing rate of 6%, whichever is greater. In no event shall the rate be less than the existing rate of 6% or greater than 8%.

SECTION 4. That Section 5.08.030 and Ordinance 353 N.S. Section B and Ordinance 226 N.S. Section 2 are amended by doubling the rates, fees and charges set forth therein.

SECTION 5. That Section 5.12.020 and Ordinance 151 N.S. Section 15 are amended by doubling the rates, fees and charges set forth therein.

SECTION 6. That Section 5.16.030 and Ordinance 225 N.S. Section 2 are amended by doubling the rates, fees and charges set forth therein.

SECTION 7. That Section 5.20.030 and Ordinance 151 N.S. Section 3 are amended by doubling the rates, fees and charges set forth therein.

SECTION 8. That Section 5.28.070 and Ordinance 165 N.S. Section 4 are amended by doubling the rates, fees and charges set forth therein.

SECTION 9. That Section 5.40.130 and Ordinance 87 N.S. Section 21 and Ordinance 224 N.S. Section 1 are amended by doubling the rates, fees and charges set forth therein.

That this ordinance shall take effect immediately as an ordinance which is necessary for the immediate preservation of the public peace, health and safety for the following reasons:

1. The passage of Proposition 13 has restricted the financial resources of the City of El Paso de Robles.

2. That an essential function of city government involves establishing a budget, before a budget can be prepared the city must be able, with reasonable accuracy, to determine the amount of income available from all sources.


3. The additional income provided by this ordinance is essential for maintenance of city functions.


