

ORDINANCE NO. 423 N.S.

AN ORDINANCE REPEALING CHAPTER 9.12 (ORDINANCE NO. 156)  
AND ENACTING NEW CHAPTER 9.12 OF THE MUNICIPAL  
CODE OF THE CITY OF EL PASO DE ROBLES

The City Council of the City of El Paso de Robles does ordain  
as follows:

SECTION I. That Chapter 9.12 (Ordinance No. 156) is hereby  
repealed.

SECTION II. That new Chapter 9.12 be enacted as follows:

SECTIONS:

- 9.12.010 Allowing minor to play.
- 9.12.020 Minor playing prohibited.
- 9.12.030 Hours allowed open.
- 9.12.040 Hours allowed to play.
- 9.12.050 Exceptions.
- 9.12.060 Penalties for violations.

9.12.010 Allowing minor to play. It is unlawful for the owner,  
occupant, proprietor, manager or person in charge of any place where any  
kind of game is played with cards or dice, to allow any minor under the  
age of eighteen years, to be in or about the particular place or room  
where such games are played.

9.12.030 Hours allowed open. It is unlawful for the owner, occupant,  
proprietor, manager or person in charge of any place where any kind of  
game is played with cards or dice, to keep such place open, or permit  
such place to be open, or allow any person to play such games in such  
place, between the hours of two a.m. and six a.m.

9.12.050 Exceptions. This chapter shall not apply to games played  
for amusement only, at the home of any person, if such home is not a place  
of public resort; or games played in lodge rooms by members of secret  
societies, where meetings are not held more often than once a week;  
provided that no charge of any kind is made for the privilege of playing  
such games.

9.12.060 Penalties for violations. Every person violating any of  
the provisions of this chapter shall be deemed guilty of a misdemeanor,  
and on conviction thereof shall be punished by a fine of not less than  
ten, or more than one hundred dollars, and in default of such fine shall  
be imprisoned in the city jail one day for each two dollars of the fine  
imposed.
