

ORDINANCE NO. 428 N.S.

AN ORDINANCE FIXING A FEE FOR COSTS RELATIVE TO
ANNEXATIONS TO THE CITY OF EL PASO DE ROBLES

The City Council of the City of El Paso de Robles does ordain as follows:

SECTION I. That Article III, ANNEXATION FEES, Chapter 21.35 be added to the Municipal Code of the City of El Paso de Robles as follows:

21.35.010 - Title. This chapter shall be known and may be cited as the "Annexation Fee Ordinance".

21.35.020 - Purpose. The purpose of this chapter is to provide a method of reimbursing the City of El Paso de Robles for administration, investigation and expenses relating to approval or disapproval of proposed annexations and other costs directly and indirectly related to annexations including on and off site development costs incurred by the city; conducting studies and impacts relating to said annexations and provide a method of financing facilities necessitated by annexation and development.

21.35.030. The City Council may, from time to time by resolution, issue regulations and set fees for the implementation of this chapter.

21.35.040 - Standards For Fees. Any fees imposed pursuant to this chapter shall bear reasonable relationship to the costs associated with staff requirements or development requirements for community needs caused by annexations or developments.

21.35.050 - Fee Required. If fees are required by resolution of the City Council, such payment shall be made at the time of request for annexation by the proponents, or upon approval of final maps and subdivision agreements, or upon issuance of a building permit, whichever occurs first requiring costs for which the city should be reimbursed.

21.35.060 - Account. Fees received pursuant to this chapter shall be paid to an Annexation-Cost Fund and used to defray direct and indirect costs of annexations.

SECTION II. This ordinance shall take effect thirty days (30) after its adoption, and prior to the expiration of fifteen days (15) from the passage hereof shall be published once in a newspaper of general circulation, published and circulated in the City of El Paso de Robles and thenceforth and thereafter shall be in full force and effect.






