

ORDINANCE NO. 430 N.S.

AN ORDINANCE AMENDING ZONING MAP ESTABLISHED BY  
REFERENCE IN SECTION 21.12.020 OF THE MUNICIPAL  
CODE OF THE CITY OF EL PASO DE ROBLES

The City Council of the City of El Paso de Robles does ordain as follows:

SECTION I. That pursuant to Section 65859 of the Government Code of the State of California the Zoning Map of the City of El Paso de Robles dated August 3, 1959 and amended May 9, 1977 shall be changed by adding thereto the following described annexations which shall be rezoned pursuant to Exhibits "A", "B", "C", "D" and "E", attached hereto and made a part hereof:

- A. Annexation No. 36 (Osborne) described as Assessor's Parcel Number 20-251-01, contiguous to the existing city boundary and bounded on the north by Scott Street and on the west by Creston Road, it also being described as all of Lot 71 and portions of Lots 50 and 69 of Rancho Santa Ysabel.
- B. Annexation No. 34 (Munari) described as being contiguous to the existing city boundary and generally bounded to the north by Niblick Road, to the west by South River Road, to the east by Charolais Road and to the east by Creston Road and further described as being portions of Lots 41, 72, 73, 74 and 42 of Rancho Santa Ysabel.
- C. Annexation No. 37 (Nock) described as APN 20-221-02 bounded on the east by South River Road and on the west by the Salinas River and further described generally as a portion of Lots 35 and 36 of Rancho Santa Ysabel.
- D. Annexation No. 40 (LaValle) described as APN's 26-131-10, 26-141-12, 26-151-10, 26-151-06, 26-151-04, 18-011-04, 18-011-07 and 18-031-03 and further described as an area lying westerly of Highway 101 north of the existing city boundary.
- E. Annexation No. 41 (Chandler) described as APN's 20-141-15, 20-141-35, 20-151-01, 20-151-02, 20-211-02, 20-211-03, 20-211-04, 20-211-05, 20-201-10 and 26-211-04 and further

being described as Lot 23 and a portion of Lots 14, 16, 17, 24, 52 and 53 of Rancho Santa Ysabel, and a portion of Section 26, T126S., R.12E., MDM. and generally bounded by the existing city boundary on the west, Linne Road on the south and Union Road on the north.


