

ORDINANCE NO. 533 N.S.

AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES AMENDING SECTION 9.04.011 AND ESTABLISHING SECTION 9.04.012 OF THE MUNICIPAL CODE AS IT PERTAINS TO THE CONSUMPTION OF ALCOHOLIC BEVERAGES IN PUBLIC

Be it ordered by the City Council of the City of El Paso de Robles as follows:

ITEM 1:

Section 9.04.011 of the Paso Robles Municipal Code is hereby amended as follows:

By deleting the following:

Consumption of alcoholic beverages on public property. The City Council may, from time to time, by resolution, specify and order posted certain recreation or park areas, which are publicly owned, as areas where it is unlawful for any person to consume any alcoholic beverage. Alcoholic beverages shall not be consumed in such areas and shall not be consumed in vehicles parked in such areas.

By adding the following:

Consumption of alcoholic beverages in public. It shall be unlawful for any person to consume any alcoholic beverage, or to have in his or her possession any bottle, can or other receptacle containing any alcoholic beverage which has been opened, or a seal broken, or the contents of which have been partially removed, upon any public street, sidewalk, alley, public parking lot or any place open to the public.

ITEM 2:

Section 9.04.012 of the Paso Robles Municipal Code is hereby established as follows:

9.04.012 EXCEPTIONS

The provisions of Section 9.04.011 shall not apply to the consumption or possession of alcoholic beverages under one or more of the following conditions:

A. Where the consumption or possession of alcoholic beverages is taking place within the fenced property of the Mid-State Fair and with the approval of the Mid-State Fair Director.

B. Where written permit to consume or possess alcoholic beverages in a specific public park, street, or other place open to the public has been obtained from the City at least 24 hours prior to said act.

Individuals, businesses, or organizations engaging in the sale of alcoholic beverages shall be properly licensed by the State of California Department of Alcoholic Beverage Control.


C. Within any business open to the public where that business has been properly licensed by the State of California Department of Alcoholic Beverage Control for on-premises sale and consumption of alcoholic beverages.

ESTABLISHED BY REFERENCE IN SECTION 21.12.020
OF THE ZONING REGULATIONS
OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA
(REZONE 87005 - MIDLAND PACIFIC)

The City Council of the City of El Paso De Robles, California, does hereby ordain as follows:

SECTION I: That the Zoning Map of the City of El Paso De Robles, dated July 1, 1977, shall be changed as follows:

A. That Section 21.12.020, MAP ALTERATIONS, be changed by providing that the following properties described on the 1986 Assessor's Rolls for the County of San Luis Obispo be rezoned as follows and as shown on Exhibit A (attached).

9-761-1 and 4 (City well sites)	R-1,PD
9-761-20 and 21	R-1,PD

SECTION II: These changes to the Zoning Map shall be incorporated into said map and become a part of said map.
