

ORDINANCE NO. 591 N.S.
 AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES
 ADOPTING CODE AMENDMENT 90001 AND
 AMENDING THE PERFORMANCE STANDARDS ADOPTED BY
 ORDINANCE 457 N.S. SECTIONS 3,4,5 (1981) AND
 ORDINANCE 536 N.S. SECTIONS 2(4) (1987)

WHEREAS, Paso Robles Municipal Code Sections 21.21.060 and 21.21.070 establish adopted performance standards for self-service petroleum sales and gasoline service stations, and

WHEREAS, the location and access requirements of a gas station, the proximity to a major thoroughfare such as an arterial, highway, or freeway, and the ability of a frontage road to absorb increased traffic generation are all issues that can be adequately met by a frontage road, whether designated as an arterial or as a collector, and

WHEREAS, at its meeting of January 23, 1990, the Planning Commission took the following actions regarding this code text amendment:

- a. Considered the facts and analysis, as presented in the staff report prepared for this project;
- b. Conducted a public hearing to obtain public testimony on the proposed code text amendment;
- c. Recommended that the City Council approve a Negative Declaration for this code text amendment;
- d. Recommended that the City Council adopt the code text amendment regarding performance standards of the Municipal Code;

WHEREAS, at its meeting of February 6, 1990, the City Council took the following actions:

- a. Considered the facts and analysis, as presented in the staff report prepared for this project;
- b. Conducted a public hearing to obtain public testimony on the proposed code text amendment;
- c. Adopted Resolution 90-24 approving a Negative Declaration for the proposed code text amendment;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of El Paso de Robles, California, that the performance standards contained within Section 21.21.060 and .070 of the Municipal Code be amended by Code Amendment 90001 as follows:

SECTION 1: Section 21.21.060 Subsection D is amended to read as follows:

D. Location and Access: Self-service petroleum sales shall be located on property having direct access to a major arterial street or to a collector street functioning as a frontage road and preferably on a corner lot at the intersection of an arterial street or a collector street functioning as a frontage road and another arterial or collector street. Access to the site shall be provided by at least two driveways.

SECTION 2: Section 21.21.070 Subsection A is amended to read as follows:


D. Location and Access: Gasoline service stations shall be located on property having direct access to a major arterial street or to a collector street functioning as a frontage road and preferably on a corner lot at the intersection of an arterial street or a collector street functioning as a frontage road and another arterial or collector street. Access to the station shall be provided by at least two driveways.
