

ORDINANCE NO. 641 N.S.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES AMENDING CHAPTER 2.04 OF TITLE II OF THE PASO ROBLES MUNICIPAL CODE RELATING TO COUNCIL MEETINGS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PASO ROBLES AS FOLLOWS:

SECTION 1: Section 2.04.010 of the City of Paso Robles Municipal Code is hereby amended to read as follows:

Section 2.04.010 - Time of Regular Meetings

The regular meetings of the City Council of the City shall be held on the first and third Tuesdays of each month at the hour of seven-thirty p.m. on said days, unless modified pursuant to sections 2.04.015 and/or 2.04.030 of this order.

SECTION 2: Section 2.04.015 is hereby added to the City of Paso Robles Municipal Code Chapter 2.04 as follows:

Section 2.04.015 - Conduct of Meetings

The City Council may, by resolution, establish policies, rules and regulations for the conduct of meetings, including order of business to be conducted, method of voting and time of adjournment.

SECTION 3: Section 2.04.030 of the City of Paso Robles Municipal Code is hereby amended to read as follows:

Section 2.04.030 - Location of Regular Meetings


All regular meetings of the City Council shall be held in the City Council Chambers of the City Hall located at 1030 Spring Street in the City of El Paso de Robles. The City Council may establish a new location for City Hall should the aforementioned premises be determined unsuitable for any reason.

SECTION 4: This Ordinance shall take effect thirty (30) days after its passage, and within fifteen (15) days after its passage, it shall be posted in three (3) public places within the City of Paso Robles, to-wit:

1. City Hall, 1030 Spring Street, Paso Robles, CA 93446;
2. United States Post Office, 800 6th Street, Paso Robles, CA 93446;
3. Paso Robles Chamber of Commerce, 548 Spring Street, Paso Robles, CA 93446.


