## RESOLUTION NO.1, 1923.

Resolution Directing Execution of Garbage Removal Contract.

BE IT RESOLVED that Ernest w.McClintock is hereby authorized upon entering into the contract hereinafter mentioned to engage in the business of removing garbage and waste matter from dwellings and other premises within the City of El Paso de Robles, under the provision of Ordinance Nine N.S., entitled "An Ordinance Providing for the Disposal of Garbage and other Waste Matter".

BE IT FURTHER RESOLVED that the charges or fees which he may collect for the removal of such garbage and waste matter shall be as hereinafter specified.

BE IT FURTHER RESOLVeD that the President of this Board be, and is hereby authorised, to enter into a contract with seid Ernest W.McClintock, under the provision of said Ordinance, for the removal of garbage and waste matter and the bodies of dead animals as defined in seid ordinance, which contract shall provide that said garbage, waste matter and bodies of dead animals shall be removed in the manner as required by said ordinance and that said Ernest W.McClintock shall have for his work and labor in the removal of said garbage, waste matter and bodies of dead animals the following compensation, to be collected as in said Ordinance specified.

Removal of garbage from residences 50¢ per month; removal of waste matter from residences 50¢ per month; removal of garbage from rooming and apartment houses \$1.50 per month; removal of waste matter from restaurants, inns and hotels \$2.00 per month; removal of garbage from restaurants, inns and hotels \$2.00 per month; removal of waste matter from restaurants, inns and hotels 50¢ per month; removing perishable goods from stores, twice weekly, \$4.00 per month; removing dry material only from stores \$2.00 per month; removing waste from garages, twice weekly, \$1.50 per month; removing dry material from small business places, twice weekly, \$1.00 to \$1.50 per month, as may agreed upon between said Ernest W.McClintock and the occupant of the premises. For each place of business requesting daily service, or service every other day, an additional charge of 15¢ per day may be made and collected; for the body of each horse or head of cattle removed and buried or burned \$5.00; for the body of each colt or calf under the age of one year removed, buried or burned \$2.00; for removing, burying or burning the body of any sheep, hog or goat \$2.00; for removing and burying or burning the body of any dog or cat or other small animal 50¢.

The said contract shall be restricted to that portion of the City of El Paso Robles lying within the following described lines:

Riverside avenue on the East, Sixth Street on the South and Twenty Fourth Street on the North, and on Filbert Street from Fifteenth Street to Eighteenth Street, and all other places, party of the first part may care to serve.

That the said contract be for a period of one year, and that the contractor have thirty days from the date of execution of said contract within which to put his carts and vehicles into the condition required by said Ordinance.
